The Wildlife Institute of India is a premier National Institute for training and research in Wildlife Conservation and Management. The Institute is looking for bright candidates for filling up of Group-A Scientific positions 02 (two) posts of Scientist-Cqand 01 (one) post of Scientist-Dqpost on Direct Recruitment (D.R.) basis. The applications are invited from

#### \* Important Note:

Out of above three posts (Scientist C: Two Posts; Scientist D: One post) one Post is reserved for the Persons with Disability under one leg effected (OL) (with both arms working), one arm effected (OA) (with both legs working)/Hearing Impairment (HH) categories from any category. Such candidate from any category (UR/SC/ST/OBC) may apply for the above posts. Interlocking reservation+ will be provided to Rersons with Disabilities+as per Government of India Instruction. Persons with minimum 40% disabilities can apply for these posts.

#### Terms and Conditions:

1. The headquarter for the above post would be Wildlife Institute of India (WII), Dehradun. However, the selected candidate would be liable to serve at any location decided by the Institute as per functional needs.

#### 2. **Age**:

- (i) **Scientist C:** Not exceeding 31 years in case of candidates possessing Masteros degree and 34 years in case of candidates having Ph.D. degree as on 28<sup>th</sup> November 2014.
- (ii) Scientist D: Not exceeding 35 years in case of candidates possessing Masteros degree and 38 years in case of candidates having Ph.D. degree as on 28<sup>th</sup> November 2014.

#### 3. Age Relaxation:

Relaxation in upper age limit shall be allowed in accordance with the Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel & Training) OM No.1501282/2010-Estt.(D) dated 27.03.2012. The categories and upper age relaxations are as follows:

- (a) Scheduled Castes and Scheduled Tribes up to 5 years.
- (b) Other Backward Class up to 3 years.
- (c) Persons with disabilities up to 5 years
- (d) SC/ST Persons with disabilities up to 10 years
- (e) OBC Persons with disabilities up to 8 years
- (f) Widows, divorced women and women judicially separated from their husbands and who are not re-married up to the age of 35 year (up to 40 years of for members of Scheduled Castes and Scheduled Tribes)
- (g) Employees of Wildlife Institute of India/Government/Autonomous Bodies/Universities employees up to 5 years.
- 4. The period of experience in the requisite discipline/area of work shall be counted with effect from the date of acquiring the prescribed minimum educational qualifications required for the post. Period spent in wildlife research/conservation will be counted towards experience.
- 5. The OBC candidates who belong to % reamy Layer+ are not entitled for concession admissible to OBC category and such candidates have to indicate their category as Unreserved (UR). The OBC (Non- Creamy Layer) candidates are required to submit requisite certificate in prescribed format (Annexure 1) of Government of India, from a Competent Authority issued in the current year. The name of the caste and community indicated in the OBC (Non-Creamy Layer) certificate must appear in the Central list of Other Backward Classes. Further, OBC (Non-Creamy Layer) candidates will have to give a self-undertaking indicating that they belong to OBC (Non-Creamy Layer) category also at the time of written test/interview, if called for.
- 6. The job requires extensive traveling to forest interiors, wildlife areas, high altitude areas and arduous terrain.

- 7. Candidates working in Government/Autonomous Bodies/Universities should submit their applications through proper channel together with a certificate duly signed by the employer/forwarding authority. They may, however, send an advance copy of the application, in the prescribed format, complete in all respects, including postal order/Bank Draft by the due date i.e. 28<sup>th</sup> November 2014 The duly forwarded application from the employer must be received at the Institute before the written test.
- 8. Shortlisted candidates will have to produce original certificates furnished in their applications at the time of interview.
- 9. Applications received after the due date i.e. 28<sup>th</sup> November 2014 without requisite fee, unsigned applications, incomplete applications and applications not in prescribed format are liable to be rejected.
- 10. Candidates who obtain appointment by furnishing false information in the application are liable to be terminated.
- 11. Postal address furnished in the application is final and no correspondence for change of address at a later date will be entertained.
- 12. Canvassing in any form will be a disqualification.
- 13. Mere fulfillment of the minimum advertised qualifications and experience requirement DOES NOT automatically entitles an applicant to be called for interview.
- 14. The Institute shall screen the applications received by due date and organize a written test for shortlisting the candidates to be called for the interview. The test for the eligible applicants shall be conducted in the Institute campus at Dehradun most likely in mid January 2015. The shortlisted candidates based on written test would be called for interview subsequently conducted at Dehradun in last week of January 2015.
- 15. No correspondence will be entertained either with regard to the call for written test, interview and/or selection.
- 16. It may be noted that if, at any stage, it is found that an attempt has been made by the applicant to willfully conceal or misrepresent the facts, his/her candidature may be summarily rejected and his/her employment terminated.

- 17. The date for determining the age limit/experience/qualifications shall be the closing date prescribed for receipt of applications i.e. 28<sup>th</sup> November 2014.
- 18. The decision of the Institute in all matters relating to eligibility, acceptance or rejection of application, mode of selection will be final and binding on the candidates and no enquiry or correspondence will be entertained from any individual or his/her agency.

#### How to Apply:

- (i) The applications should be sent in the prescribed proforma (Annexure-2) typed out on A-4 size paper 210x297 mm) accompanied by crossed Indian Postal Order/Bank Draft of the value of Rs.1000/- (Rupees One Thousand only) drawn in favour of Director, Wildlife Institute of India, payable at Dehradun. Fee is non-refundable. Women candidates and Persons with Disabilities are exempted from payment of fee.
- (iii) Applications should be accompanied by self attested copies of certificates of age, educational qualifications, experience, and claim of belonging to OBC (Non-Creamy Layer) and PWD category. The original certificates would be required at the time of interview.

Applications from abroad and from those in the Andaman & Nicobar Islands, Lakshadweep, State/Union Territories in the North Eastern Region, Ladakh division of the Jammu & Kashmir State, Sikkim, Panaji Sub-division of Chamba, Lahaul & Spiti Districts of Himachal Pradesh should reach upto 05.12.2014.
