NOTIFICATION

Whereas the Governor, Himachal Pradesh, after careful consideration is of the view that the areas mentioned in the Schedule below are of adequate ecological, faunal, floral, geomorphological, natural and Zoological significance.

Now therefore, the Governor, Himachal Pradesh, in exercise of the powers vested in him under Section 18 (1) of the Wild life (Protection) Act,1972, is pleased to declare his intention to constitute the aforesaid areas as extension to the Lipa Asrang Wild Life Sanctuary Notified vide No.FFEB-F(6)2/99-II dated 7th September, 2001, for the purpose of protecting, propagating, or developing wild life, or its environment.

The situation and limits of such areas comprising of 318 sq. km (Related Survey of India, survey sheets No.53-1/1, 2, 5 and 6; Scale 1:50,000) west to Lipa Asrang Wild Life sanctuary shall be as under:-

(Lat 31° 41' 20" N, Long 78° 18' E)</p> <p>South: From 3728 m (Lat 31° 41' 20" N, Long 78° 18' E) down to Taiti Garang (Khad) along naia, from there boundary follows Taiti Garang along northern boundary of existing <u>Lipa Asrang Wild Life Sanctuary</u> meeting point with Drimbling Gad. From there the boundary lies up stream along Drimbling Gad to Drimbling Glacier (5168 m), then west along the ridge passing through Shangla Dhar peak, 5480 m, finally to 5914 m (Lat 31° 41' 50" N, Long 78° 7' 30" E)</p> <p>West: From 5914 m. (Lat 31° 41' 50" N, Long 78° 7' 30" E) the boundary follows Tehsil boundary / footpath via 5597 m, 5567m, 5495m, 5320m to 5470m. From there the boundary turns north via 5540 m, 5848m, 5685 m to 5635m, (Lat 31° 51' 20" N, Long 78° 5,30" E).</p>

Area: This area of 318 sq. km. shall constitute extension of the existing 31 sq. km. area of Lipa Asrang Wild Life Sanctuary thus making a total of area **349 sq.km.**
