- (1) The last date for receipt of quotation is... 21-02-2014 upto 1700 hrs
- (2) The equipment being quoted should be of Original Equipment Manufacturer (OEM) of reputed company and no non-standard equipment will be accepted by the Institute.
- (3) The bidder must be Original Equipment Manufacturers (OEM) or their Authorized Distributors in India. An authorization certificate issued by the OEM should be attached with the bid; failing which their offer will not be considered by the Institute.
- (4) Offer should be valid for a minimum period of 120 days from the date of opening of quotations.
- (5) The Offer should be completed in all respects and contain all information asked for above information.
- (6) The supplier should indicate brand/make and full details of the equipment being quoted. Supplier must submit complete technical specifications, without leaving any scope for ambiguity. All supporting leaflet, brochure, technical information literature, catalogues, vendor profile must be attached.
- (7) The firm should submit attested copy of TIN number and PAN number in Bid; failing which their offer will not be considered by the Institute.
- (8) If the bidding agency does not meet the above parameters and does qualify technical parameters/specifications as given in the above Table, their offer will not be considered and shall be rejected by the Institute.
- (9) **Warranty:** You are required to give a warranty for a minimum period of one year from the date of satisfactory supply, inspection and acceptance of the equipment in good condition. If during warranty period, the equipment supplied fail to give satisfactory performance and found defective, you will rectify the defect within a reasonable time; failing which the equipment should be replaced with new one(s) without any cost.
- (10) You may submit your rates/offer for the item(s) in the following format only.

**Note:** Rates should be quoted only in accordance with the above mentioned table; failing which their offer is liable for rejection.

- (11) **Prices:** You should quote your rates on a fixed price on FOR, Wildlife Institute of India, Chandrabani, Dehradun basis. Agency would be required for its delivery to the Institute. The taxes/VAT, if any should be clearly mentioned. The prices should be quoted only in Indian Rupees. No price variation shall be allowed relating to increases in dollar price variation, etc. Price quotation accompanied by vague and conditional expressions such as "subject to immediate acceptance", "subject to confirmation before sales" etc. will be treated as being variance and shall be liable for rejection.

- (12) If any of the given specifications/parameters does not meet the required specifications as mentioned above, their offer will not be considered and shall be summarily rejected by the Institute.
- (13) **Comparison of Rates:** Comparison of Rates shall be made on item wise equipment only. Rates for comparison will be taken after adding the taxes, freight, insurance etc. and FOR, Wildlife Institute of India, Chandrabani, Dehradun.
- (14) **Payment:** 90% payment shall be released on bill basis after entire supply, inspection and acceptance of the equipment in good condition. Balance 10% payment shall be released after completion of warranty period **OR** the said balance 10% payment may be released against Bank Guarantee/FDR pledged in favour of Director, Wildlife Institute of India, Dehradun.
- (15) **Delivery:** Agency would be require to supply the equipments within a period of eight <sup>weeks</sup> from the date of issue of supply order, if placed with your firm.
- (16) **Penalty:** Penalty @ 0.5% per week will be charged for late supply subject to a maximum of 5% on the amount of equipments which have been supplied late.
- (17) No Form 'C' or 'D' or any other concessional Sales Tax form will be issued by the Institute. Only Form-16 (Road Permit) for transportation of equipment within India shall be provided by the Institute.
- (18) The above quantity of the equipments are approximate, the same may be reduced or increased at the time of issuing supply order(s), depending upon the requirement of the Institute.
