1. Introduction

7. Evaluation Process

A Committee duly constituted by Wildlife Institute of India will carry out a preliminary screening of all the received bids and will shortlist the bidders fulfilling the prescribed requirements. Selection Committee reserves the right to accept or reject any or all the bids at any time prior to award of contract/order, without assigning any reasons and without incurrence of any liability on Wildlife Institute of India.

8. Other Terms and Conditions:

- Application submitted by the firm(s) in the prescribed "Application Form" only will be accepted.
- All pages of "Application Form" shall be signed by the authorized representative of the Firm. Prescribed "Application Form" may be obtained from www.wii.gov.in or from Wildlife Institute of India.
- The firms may submit their registration forms either by Post /Courier or by hand within stipulated schedule.
- In case of Accredited Agents and Authorized Dealers/Stockiest, satisfactory evidence from their Manufacturers shall be submitted along with the completed application form.
- Preference will be given to those firms who are on the approved list of Govt. Dept. And Public sector Undertakings or ISO Certificate holders or dealers authorized by manufacturers.
- The registration as "Approved Supplier" will be kept valid for a period of 01 year. However, it will be reviewed, once in a year, eliminating firms which may have gone out of business or whose performance has been found unsatisfactory.
- Tenders/quotations will be invited on requirement basis only.
- The Firm/Supplier should have registration with state & Local Authorities for undertaking the profession (Copies of proof to be enclosed)
- In case of any incomplete information/documentation, The Director, WII has right to reject the application form or cancel the registration of the firm. Without PAN, GST Number and complete address with PIN code and all relevant documents, no firm will be registered. The Director, WII reserves the right to cancel the name of the supplier/ firm / service provider from its approved lists at its absolute discretion without assigning any reasons. No refund of fee will be made in any case
- If WII registers any Firm as approved Supplier he has to supply the material F.O.R. WII. The
 agency has to accept the WII payment terms i.e. Payment shall be made by Crossed
 Cheque/ RTGS.
- Any change in address, phone number, Fax no. And Email Id shall be informed to WII
 immediately, so as to have proper communication with these Firms/Manufacturers.
- In case of empanelled vendor is found in breach of any terms & condition(s) of WII or supply/work order, at any stage during the course of supply / installation or warranty

period, the legal action as per rules/laws, shall be initiated against the vendor and EMD/Security Deposits shall be forfeited by WII, besides debarring and blacklisting the vendor concerned for at least three years for further dealings with WII.

- The vendor should not assign or sublet the empanelment or any part or it to any other vendor in any form. Failure to do so shall result in termination of empanelment. Any vendor can get registered and empanelled any time throughout the year. All those firms which are registered and confirmed shall be entertained for various queries.
- All registered firms are expected to maintain absolute integrity, follow a decent standard of business ethics and do nothing unbecoming of a registered supplier.

Force Majeure

- (a) However, the Agency shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- (b) For purposes of this Clause, "Force Majeure" means an event beyond the control of the Agency and not involving the Agency's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Institute either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- (c) If a Force Majeure situation arises, the Agency shall promptly notify the Institute in writing of such conditions and the cause thereof. Unless otherwise directed by the Institute in writing, the Agency shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- Resolution of Disputes: All disagreements, disputes, difference that may arise between
 the Wildlife Institute of India and the Supplier which cannot be resolved through mutual
 negotiations shall be referred to an Arbitrator appointed in accordance with the provisions
 of relevant Indian Law. The venue of the proceedings and arbitration shall be Dehradun,
 Uttarakhand, India.
- **Jurisdiction:** The obligations and liabilities arising out of this contract shall be construed in accordance with the laws of Union of India. The Court in Dehradun, Uttarakhand, India shall have the exclusive jurisdiction to try all or any of the dispute.
