Wildlife Institute of India (WII), Dehradun, an autonomous institution of Ministry of Environment, Forest and Climate Change of Govt of India) has been conducting research and conservation activities on Ganges River Dolphin and associated aquatic fauna as a part of its project 'Development of conservation action plan for river dolphins'. - Boat length should be minimum 18 meters. 2.
- Boat breadth (middle of hull) should be minimum 4 meters. 3.
- Boat can run in minimum one-meter water depth. 4.
- Boat should be fitted with engines minimum 45 HP (low noise and low vibrations). 5.
- Boat should have accommodation facilities with separate kitchen and attach toilets for minimum 10 6. persons for comfortable stay during continuous river surveys.
- Boat should be equipped with 2 observer's platforms, working spaces, water storage, power supply, 7. and adequate power back up.

- 8. Boat should have valid registration, insurance and other related documents.
- 9. Boat should have minimum 4 staff for its operation.
- 10. Boat and its staff should have experience of working on scientific surveys.
- 11. Boat will be physically examined by WII staff for checking boat hygiene and staff quality before hiring the same.

- 13. The Institution is registered with the Department of Scientific & Industrial Research, New Delhi. Under Central Tax (Rate) / Integrated Tax (Rate) Exemption Certificate in terms of Notification No. 45/2017-Central Tax (Rate)/ No. 47/2017 Integrated Tax (Rate), Dated 14.11.2017 issued by Ministry of Finance, Department of Revenue of Government of India, the GST is leviable on the goods thereon at concessional rate, calculated at the rate of 5%. The Bidder should indicate brand/make and full details of the boat and submit complete technical specifications, without leaving any scope for ambiguity and must also attach technical information Pictures, literature, leaflets, catalogues, brochures etc. The bidder must ensure that the quotation submitted is in accordance with the requirements/specifications of WII.
- 15. Offer should be valid for a period of one month from the date of submission of quotations.
- 16. **Prices**: The taxes/VAT, if any should be clearly mentioned. The prices should be quoted only in Indian Rupees.
- 17. WII intends to hire Motor Boat for the above purpose for a period of three years. The contract will be renewed yearly on annual basis based on the satisfactorily supply of the Motor Boat and to the satisfaction of the User Officer.
