The supplier should indicate brand/make and full details of the equipment and submit complete technical specifications, without leaving any scope for ambiguity and must also attach technical information literature, leaflets, catalogues, brochures etc. The supplier must ensure that the quotation submitted is in accordance with the requirements/specifications of WII.
- 4. Offer should be valid for a period of one month from the date of submission of quotations.
- 5. Warranty: You are required to give a warranty as mentioned/indicated above in the table from the date of satisfactory supply of the equipment. If during warranty period, the equipment supplied fails to give satisfactory performance and found defective, you will rectify the defect within a reasonable time; failing which the equipment should be replaced with new one(s) without any extra cost.
- 6. Prices: You should quote your rates on a fixed price on FOR, Wildlife Institute of India, Chandrabani, Dehradun basis. Agency would be required for its delivery to the Institute. The taxes/GST, if any should be clearly mentioned. The prices should be quoted only in Indian Rupees.

- 7. The Institution is registered with the Department of Scientific & Industrial Research, New Delhi. - 12. Payment: 97% payment shall be released on bill basis after entire supply and inspection, acceptance and installation of the equipments in good condition. Balance 3% payment shall be released after completion of warranty/guarantee period OR the said balance 3% payment shall be released against Bank Guarantee/FDR pledged in favour of Director Wildlife Institute of India, Dehra Dun. The same shall be released after successful completion of the warranty period.

- 13. **Delivery**: Agency would be require to supply the equipment within a period of four weeks from the date of issue of supply order, if placed with your firm.
