Ref: Office Memorandum No. A/1/3-29/2010-WII, dated 01.02.2019 of Wildlife Institute of India, Chandrabani, Dehra Dun - Recruitment and Promotion Rules for Administrative/Finance posts - 2019 reg. Kindly provide following documents/information regarding above O.M. under Right to Information Act 2005 : 1. Details of sanctioned strength of posts of Administrative and Finance cadre with their Pay Scale/Pay Band and Grade Pay as on 13.12.2017. 2. In present Recruitment and Promotion Rules for Administrative/Finance posts - 2019, Annexure -3, on page 5 under para 13 (categorization of the posts in Wildlife Institute Of India after adoption of the revised Recruitment Rules) at Serial No. 6 the post of Administrative Officer (PB-3, Grade Pay -5400, Pay Matrix Level - 10) has been re-categorized as Deputy Registrar (PB-3, Grade Pay -7600, Pay Matrix Level -12). Regarding this kindly provide the following information : (a) Grounds/necessity/ requirement on the basis of which it was felt/decided that the post of Administrative Officer would be re-categorize as the post of Deputy Registrar with enhance Grade Pay of Rs. 7600 and Pay Matrix Level 12. (b) Certified photocopy of official proceedings through which it was initiated, recommended and approved by the competent authority that the post of Administrative Officer would be re-categorized as the post of Deputy Registrar with enhance Grade Pay and Pay Matrix Level. (3) As per Recruitment Rules adopted and implemented by the Institute in year 1986 the posts of Administrative Officer and Finance Officer were analogous posts with similar scale of pay. Pay Scales of both above posts were upgraded to the Pay Scale of 2375 - 3500 in the G.B. meeting held on 01.05.1992. The posts of Internal Audit Officer and Academic Officer were also created in same Scale of pay (2375-3500) on 10.04.1993 and 26.03.2001 respectively and added in the cadre of Administrative/Finance posts of WII. The Recruitment Rules of the Institute again revised/adopted and implemented in year 2007 and all the four above posts were having same status in these rules also. Regarding this kindly provide the following information : (a) On what legal basis/grounds in the Recruitment and Promotion Rules for Administrative/Finance posts - 2019 the only post of Administrative Officer has been re-categorized as Deputy Registrar with enhance Grade Pay and Pay Matrix Level and the other incumbents holding posts of Academic Officer, Finance Officer and Internal Audit Officer were deprived from their genuine legal right.


