
Dear Sir,

After receiving an additional amount of Rs. 184/- vide receipt no. 15732 dated 02.01.2020, reply of the information is being enclosed herewith





OFFICE MEMORANDUM

- Sub: (1) Recruitment and Assessment Promotion Rules for Group-A Scientific Posts – 2019
- (2) Recruitment and Assessment Promotion Rules for Technical and Support Staff – 2019
- (3) Recruitment and Promotion Rules for Administrative/Finance Posts – 2019

The Governing Body in its 66th meeting held on 14.12.2017 constituted a Sub-Committee under the chairmanship of ADG(WL), MoEFCC to review the Recruitment and Promotion Rules of (i) Group A Scientific post; (ii) Technical & Support Staff; and (iii) Administrative and Finance Posts at the Institute on the lines of CSIR. The Sub-Committee had submitted its report making recommendations for amendments/revisions and adoption of Recruitment and Promotion Rules in respect of all three categories of posts.

The Finance Committee in its 33rd meeting held on 30.10.2018 under the Chairmanship of DGF & SS had endorsed the recommendations of the Sub-Committee for approval by the WII-Governing Body. The Governing Body in its 68th Meeting held on 09.11.2018 approved the recommendations of the Sub-Committee and directed that these should be sent to the IFD of MoEFCC. The IFD of MoEFCC has made certain observations and approved the Recruitment Rules. The observations made by the IFD of MoEFCC have been duly incorporated in the Revised Recruitment Rules. The Revised Recruitment Rules are adopted in WII w.e.f. 01.04.2006 but no financial arrears will be paid. The financial benefit will be allowed only w.e.f. 01.02.2019 i.e. from the date of issue of this Office Memorandum. The Revised Recruitment Rules supersedes the existing Recruitment Rules for all the three categories and the Revised Recruitment Rules are attached as per details given below:-

- (i) Recruitment and Assessment Promotion Rules for Group-A Scientific Posts – 2019 (Annexure-1)
- (ii) Recruitment and Assessment Promotion Rules for Technical & Support Staff – 2019 (Annexure-2)
- (iii) Recruitment and Promotion Rules for Administrative/Finance Posts – 2019 (Annexure-3)

The new Annual Appraisal Performance Report (APAR) in respect of Group-A Scientists and Technical & Support Staff will be effective from the Financial Year 2019-20.
