<p>To The Director Wildlife Institute of India</p> <p>This is for kind consideration as there are evidently various death due to radio collaring of tigers due to various reason , from the Tigers were radio collared and many Animals like Gaur Bison their deaths have increased. Now the program which is started for Elephant Radio Collaring is inhumane is unacceptable and just massaging own egos as scientist, there are is analysis and monitoring.</p> <p>Tigers During pregnancy and during rainy season and winters gain weights and collar becomes tight in their neck and several animals has been choked to death, same media reports have been reported through the various post mortem reports as released. After a certain period radio collar gets malfunctioned and still they are around the neck of animals. Wild Animals are not pet animals, radio collar is not required for wild animals, they may get stuck in here and there pr in territorial fight and cant unhold grips.</p> <p>In the view of above facts it is to be treated as a representation with an intention to file a litigation for seeking remedy through Honble Court Once we see that there is no further remedy available with WII as authority who launched this program and below prayed accordingly. This may be treated as a representation on 3 weeks w.e.f 16.10.2020</p> <p>1. to put on hold the elephant Radio Collaring Program and remove the Collar of the Elephant Currently radio collared(Interim Relief) 2. Radio Collars may be replaced with MicroChips , microchips are long lasting duration and less troublesome to wild animals. 3. Death Analysis report of Tigers Death due to radio collar is requested in this regard. 4. If any research has been done post radio collaring Tiger may be floated on Public Platform with scientific reports 5. Funds Utilisation, Stock Register, Sale and Purchase register may be scrutinised and be annexed and provided with investigation report.</p> <p>Any Animals death due to radio collar shall be cost and consequences of Wildlife Institute of Dehradun and may be presented before the Honorable Court as willful hunting of Wild Animals an email was presented to NTCA in this regard on 14.08.2020 and no response has been received, however this program has now started for Elephant which is inhumane.
