Sir/ Madam Please refer to extract of note sheet **WII/ ADM/STR/2012-13/116** dated 20.01.2021 against Tender Notice No. WII/ADM/STR/2012-13/116 towards contract "Engagement of Chartered Accountant" vide Online Tender, invited in two bid system under e-procurement through Central Public Procurement Portal.

Sir / Madam, the extract note mentions disqualification of our Firm M/s Rawat Nakoti & Co. We would like to categorically refer "Tender Opening Minutes (Technical Bids)" dated **27 Nov 2020**, wherein it is specifically mentioned that "**The representative from the firms were not present at the time of Tender Opening**" on 27 Nov 2020 at 4.00PM signed by Mr A.K Dubey (Purchasing officer) **at 27 Nov 2020 at 16:20 PM time.**

Sir/ Madam, we would like to affirm our strong objection on the said point as our representative Mr Arun Rawat & Mr Vinod Diwakar were personally present on the said date at the venue of tender opening. Our representative was present there till 5:00 PM and it was told by Mr A.K Dubey (Purchasing officer) that as no other participants were present at the venue, hence tender could not be opened and we will further inform you as and when it will be opened within a week time.

Sir/ Madam, we were not in receipt not informed of any further information towards opening of said tender by the said authority and we were not given any opportunity of being heard.

Further , As per Chapter 3 of tender document " Eligibility criteria for Technical Evaluation of Bidders" POINT NO 7 Specifying clearly that " The firm must have their Head Office / Branch Office in DehraDun, proof of which should be attached with the bid ; failing which the offer will be rejected"

We would like to tell u that, Bidder M/s J. N Gupta & Co, Chartered Accountant got technical qualified in the Tender, whereas as per office records of the Institute of Chartered Accountant of India (ICAI) dated 26 Oct 2020 , Firm is not having any HEAD OFFICE / BRANCH OFFICE at DEHRADUN. Hence as per tender rules the said firm offer must had been Rejected.
