

Implementation of 6 th Pay Scales to Scientist G in the Grade pay Rs.10,000 in various institutions under the Ministry	The recommendations of 6 th CPC were accepted by the GoI and the Ministry of Finance, Department of Expenditure has issued a notification no. GSR622 (E) dated 29.08.2008. The pre-revised pay scale of Rs.18,400-500-22400 of Scientist G in WII (as per 5 th CPC) was revised to pay band 4 grade pay 10000 (as per 6 th CPC) w.e.f 01.01.2006. The same has been implemented in Wildlife Institute of India.
2.	Certified copies and Administrative orders for Grade Pay in respect of Scientist G for the period from 2007 to 2010	The Wildlife Institute of India, Dehradun is an autonomous body of the Ministry of Environment, Forest and Climate Change (MoEFCC), New Delhi. The institute has implemented the pay scales of WII employees as applicable to post carrying identical pay scales in the Central government as revised from time to time and as per approval of the Governing Body of the institute. The Grade pay of Rs.10000 to the employees holding the position as Scientist G was allowed from 01.01.2006 to 31.12.2015. No separate orders for the period 2007 to 2010 are available.
