## Revised rules for the award of research fellowship and guidelines to engage Research Personnel at Wildlife Institute of India

### Selection procedure to engage JRF, SRF & RA at WII

The existing rules/criteria for the selection of JRFs/SRFs and RAs (as approved by TRAC and GB), have been derived from UGC/CSIR norms. However, these organizations have changed their rules during recent years. Since, Wildlife Science is a multi-disciplinary subject, it is proposed to include candidates from Humanities/Social Sciences in its ambit. Revised (proposed) procedure for the selection of JRFs/SRFs and RAs is as follows:

- a) The selection of the advertised JRF/SRF positions at WII shall be done through a Qualifying Test followed by interview, three times a year.
- b) Announcement of the JRF/SRF position(s) shall be made through a window advertisement three times a year in one of the National Daily Newspaper (English) and WII's website at least 45 days in advance.
- c) An 'Expert Committee' constituted by the Director, WII, shall conduct the personal interview for the selection of JRFs/SRFs. The panel of committee shall comprise of Dean, Faculty of Wildlife Science as Chairperson; One External Subject Matter Expert; Research Coordinator; two senior Faculty Members (Scientist-E and above); and concerned PI(s) of the Project.
- d) During the interview, the Committee would test the candidate for his/her knowledge of the subject, scientific temperament, aptitude for wildlife research, creative ability and interest.
- e) There shall be 3 components, based on which selection merit would be arrived at as follows:

f) The cut off criteria for interview would be a minimum of 50% marks in written test.

# Selection procedure to engage research fellows other than JRF, SRF & RA at WII

- a) The selection of the advertised positions other than JRF, SRF & RA at WII viz., Junior Project Fellow/Senior Project Fellow/Project Associate/Junior Technical Assistant/Senior Technical Assistant or any other category as approved in the respective project, shall be done through a Qualifying Test followed by interview.
- b) Announcement of the position(s) shall be made through a window advertisement three times a year in one of the National Daily Newspaper (English) and WII's website at least 45 days in advance.
- c) An 'Expert Committee' constituted by the Director, WII, shall conduct personality test. The committee would consist of the Dean, Faculty of Wildlife Science as Chairperson; Research Coordinator; two senior Faculty Members (Scientist-E and above), One External Subject Matter Expert and concerned PI(s) of the Project.
- d) During the interview, the Committee would test the candidate for his/her knowledge of the subject, scientific temperament, aptitude for wildlife research, creative ability and interest.
- e) There shall be 3 components, based on which selection merit would be arrived at as follows:

Component	Marks
Academic Background	20% (10% UG+10% PG)
Qualifying Test*	50% (25% General + 25% Subject)
Interview	30% (Inclusive of research experience & publications)

- f) The cut off criteria for interview would be a minimum of 50% marks in written test.
- g) A short list of 'wait-listed' candidates shall be maintained valid for a period of one year. In case of any urgent requirement for a project/activity, the PI(s) with the approval of the Dean and Director may select the candidates from the pool.

### Rules for the award of Research fellowship at WII other than JRF & RA

It is informed that the Institute has implemented the rules and regulations for engaging JRF and RA as per the approval of TRAC and Governing Body. These rules are based on the lines of CSIR. However, the Institute is also required to engage research personnel under various categories such as Project Biologist, Project Assistant, Project Fellow and Research Biologist under various externally funded research projects as per the approved project by various funding agencies. These additional categories are owing to different nature of projects, varying duration and expected outputs. It is felt that there is a need to consolidate the rules and regulations regarding the selection of research personnel such as Project Biologist, Project Assistant, Project Fellow and Research Biologist and the same are given as **Annexure–V**.

### Rules for the award of Research fellowship at WII other than JRF & RA

### 1. Eligibility

- 1.1. Essential Educational Qualification: The essential educational qualifications will be specifically determined by the individual project needs.
- 1.2. Desirable Qualifications: The desirable qualifications pertaining to research experience will be specifically determined by the individual project needs.
- 1.3. Age: The age criteria, upper age limit and age relaxation if any for candidates belonging to SC/ST/OBC/Women and Physically Challenged applicants will be determined by the individual project needs.

### 2. Selection Procedure

- a) Announcement of Research Personnel (Project Biologist, Project Assistant, Project Fellow and Research Biologist) positions will be made in one of the National Daily Newspapers (English) and WII's website well in advance.
- b) The following criteria will be used for short listing the candidates for attending the interview:

- c) The candidates selected by the Screening Committee will be called for interview. The 'Expert Committee' recommended by the Dean, FWS and approved by the Director, WII, for interviewing the candidates will consist of the Dean, Faculty of Wildlife Science, External Subject Expert (1), the Research Coordinator, two senior Faculty Members (Senior Reader and above) and concerned P.I. of the Project.
- d) During the interview, committee would test the candidate for his/her knowledge of the subject, aptitude for wildlife research, creative ability and sincerity. Interview will be of 50 Marks in total. Final selection of the candidate will be based on the total marks (100 marks) obtained from screening of application as per the criteria mentioned above in point 'b' (50 Marks) plus the Interview marks (50 marks).

- e) Candidates are expected to join within 30 days from the date of issue of the fellowship offer, failing which the offer may be cancelled. However, in exceptional circumstances the Dean, FWS may grant an extension of maximum one month to the deserving candidate.
- 3. Fellowship and Tenure: As per the requirement of the project and, subject to the approved position and availability of funds.
- 4. Terms and conditions for the award of Fellowship as Research Personnel (Project Biologist, Project Assistant, Project Fellow and Research Biologist)
  - The engagement is purely on temporary basis for a period of two years from the date of joining the Institute.
     However, the same can be extended by the Institute, depending upon the exigencies of work at its sole discretion.
  - 2. Offer of engagement is subjected to his/her being found medically fit. For this purpose he/she is required to submit a medical fitness certificate issued by a Registered Medical Practitioner at the time of his/her joining.
  - The engagement in the project at WII does not give any assurance of guarantee for subsequent employment in the institute. It is purely occasional and does not entitle to any regular employment in the services of the Institute.
  - 4. During the tenure of engagement at WII, he/she will be governed by the office orders, rules and regulations of the Institute passed from time to time as are/or will be made applicable from time to time.
  - 5. During the term of engagement, he/she will be paid the fellowship and HRA as applicable and the emoluments may be revised subject to the notification from the funding agencies from time to time. He/She will not be entitled to any other allowances, bonus, LTC and/or retirement benefits as are admissible to regular employee of the Institute.
  - Even during the said period of engagement, the offer can be discontinued without giving any notice and without assigning any reason thereof.
  - 7. On the expiry of the said period or at the end of the extended period, the term of engagement as Research Personnel will automatically come to an end.
  - 8. At the time of joining the Institute he/she will have to submit two financial sureties from responsible persons (viz. Group 'A' and 'B' employees of Central Government/State Government/Autonomous Institutions under Central/State Government, Universities, etc.) for Rs. 50,000/- (Rupees Fifty Thousand only) each. He /She will also produce at the time of joining copies of documents related to educational and professional experience, certificate regarding his/her release from his/her present employer, if any.
  - Travel Rules: The Project Fellow is eligible to claim TA/DA as admissible in accordance with the rules of the Institute for any tour undertaken by him/her during the tenure of engagement.
  - 10. Leave: The Project Fellow will be entitled to avail usual casual leaves (08) per year and will seek prior approval from the Nodal Scientist/PI of the Project. The Director, WII under special circumstances may consider sanction of leave without or without monthly emoluments. In case, a Research Personnel proceeds on leave before termination of offer, he/she must join back duty before the expiry of tenure, failing which the tenure will be deemed to have terminated with effect from the date he/she proceeded on leave. A prior

- approval of the Director, WII is mandatory for the Research Personnel to visit a foreign country for attending conference/seminar/symposium, etc., related to the research activities of the project.
- 11. HRA: The House Rent Allowance (HRA) shall be paid as per the rules of the Institute/Funding agency subject to the condition that HRA payable, in no case, shall be more than the rates payable to Central Government/WII Employee(s) in that area. The basis for calculating HRA will be the monthly consolidated emolument paid to the Research Personnel.
- 12. DA, CCA, HCA, etc.: Not entitled to these allowances.
- 13. Medical Benefits and Insurance: Medical reimbursement for self through government approved medical practitioners will be provided subject to a maximum cost ceiling of Rs 5,000.00 (Rupees Five Thousand only) during the contractual period of one year based on submission of duly certified bills. A Medi-claim Policy for the self may be taken. The Institute would reimburse the premium paid for the policy of Rs. 5.0 lakhs (Rupees Five Lakhs only) annually upon production of receipt. The Medi-Claim Policy will not be allowed after end of contractual service in the Institute. An Accidental Insurance Policy for a maximum amount of Rs. 5.0 lakhs (Rupees Five Lakhs only) will be provided by the Institute and the annual premium will be paid by the Project.
- 14. Field Equipment: For research purpose the Institute may issue various field equipment/kits as per the requirement of the project and also subject to having budgetary provisions. These items will be Institute's property. The supervising faculty will ensure return of the permanent stores /non-consumable items at the time of conclusion of the Project.
- 15. Field Dress Allowance: Research Personnel will be allowed to avail Field Dress Allowance for field shoes and uniform from the Project fund and as per provision in the project budget. The amount not exceeding Rs. 2,500/- may be sanctioned for field dress/uniform to the Research Personnel or as amended from time to time.
- 16. Contingency Grant: The contingency grant as approved in the Research Personnel will be fully controlled by the Nodal Scientist/PI of the project but will be subject to usual scrutiny in finance. The concerned Supervisor/Nodal Scientist will be fully responsible for its utilization and he/she will be free to recommend disallowing of any unjustified expenditure. The Dean, Faculty of Wildlife Sciences on recommendations of the Nodal Scientist would sanction tour/forest advance(s).
- 17. Publication/Patent: The results of research work will be encouraged to publish in standard refereed journals as well as other popular forms of scientific documentation at the discretion of the Nodal Scientist/PI of the project. Due authorship will be given to the Research Personnel and other team members, who have contributed to research papers and patents. The Nodal Scientist/PI of the project will be responsible for a fair and just authorship order. In case of any dispute, the Dean, FWS will be responsible to resolve it amicably. Due acknowledgement will be given to all funding agencies in all publications arising out of research work conducted at WII. The right to commercial exploitation of the results and patent arising out of the investigation will, however, rest exclusively with WII. In case of Project funded by other agencies or collaborative research project(s), the commercial exploitation of the results and patent arising out of the research work will be worked out as per the Memorandum of Understanding (MoU) signed between the collaborating parties or as per the guidelines of the concerned funding agency.
- 18. Identity Card: Institute will issue an identity card to the Research Personnel. For this purpose the Research Personnel should furnish requisite information to the Administration section.



- 19. Transport Facility: Both for the POL and its maintenance and also in the event of having jeep/motor cycle as per the requirement in the field research and having provisions in the project budget, the Research Personnel will be required to maintain logbook, which will be, scrutinized by the concerned supervising faculty/Nodal Scientist and Finance Section as and when required.
  - 20. The following are the responsibilities that a Research Personnel is expected to meet:
    - a. He/she must be a full time research/technical worker and submit him/herself to the discipline and regulation of the Institute in which he/she is working. The supervisor/Nodal Scientist may ensure regular attendance of the Research Personnel by keeping an attendance register.
    - b. In case, of the Research Personnel desiring to appear for any competitive examination, he/she must inform the Director, WII in writing and obtain written approval before applying. He/she should submit his/her application through the Nodal Scientist/PI of the project and Dean, FWS.
    - c. The Research Personnel shall be required to submit a detailed report on the progress of his/her work to the Nodal Scientist/PI of the project who in turn shall submit a copy of the progress report to the Office of the Research Coordinator. Once a Research Personnel accepts the fellowship and joins the Institute, it is obligatory for him/her to continue for the normal tenure.
    - d. The Research Personnel shall not be allowed to discontinue his/her fellowship without the prior approval of the Nodal Scientist/PI of the Project and the Director, WII. In case, he/she wants to discontinue prior to the completion of the tenure or the attainment of original objective of the research, he/she must submit resignation to the Director, WII through the Nodal Scientist/PI of the project at least one month in advance indicating specific reasons for not continuing for the full term. In case he/she leaves the Fellowship without prior approval of the Director, WII, he/she will be liable to make such refund as may be decided by the Director, WII. The monthly emoluments shall be ceased from the date stipulated by the Director, WII while accepting the resignation.
    - e. Before the termination or resignation of the offer, a Research Personnel must furnish a detailed report of the work done during the entire tenure through including field data the supervisor and Nodal Scientist/PI of the project to the Director, WII.
    - f. Any kind of paid or honorary part-or-fulltime employment or private even in honorary capacity by the Research Personnel is not permissible during the engagement tenure at the Institute.

Director, WII, welcomed the Chairman and members of the TRAC and thereafter with the permission of Chairman, agenda items were deliberated upon one by one.

### Agenda Item No. 1

Confirmation of the Minutes of the XXXI meeting of the Training, Research & Academic Council held on 17th February 2014

XXXI meeting of the Training, Research & Academic Council was held on 17th February 2014 in WII Campus, Dehradun. The minutes of the meeting were circulated to the members vide letter No. WII/RES/TRAC-31st Meeting/A. 2.34(I) dated 8th March 2014. No comments on the minutes were received. The minutes were therefore confirmed.

### Agenda Item No. 2

### Action taken report on the decisions of the previous meeting

- Final project reports due for submission: The TRAC noted the information provided by I. the Member Secretary that the final reports of two Grant-in-aid research projects titled "Ecology of lions with emphasis on the agro-pastoral landscape of Greater Gir Ecosystem" and "Status survey and conservation of Himalayan Crocodile Salamander (Tylototriton verrucosus) in the Eastern Himalayas. (Phase-I)" have been submitted by the respective PIs and the same shall be accepted by the Director, WII, subsequent to the presentations made by the PIs to the faculty. The TRAC complimented efforts by the Dean and Director for reducing the number of pending final reports to zero.
- Research Seminar for Field Managers and Scientists from other organisations/ II. institutions along with the Annual Research Seminar of WII: Chairman, TRAC appreciated the efforts of the Institute for conducting a workshop for Field Managers and Scientists on 'Human-Wildlife Interactions and Management of Invasive Species' at WII on 23rd & 24th July, 2014. The Member Secretary informed TRAC that the Institute is in the process of preparing policy briefs regarding the management of Invasive Species and Human-Wildlife Interactions as the outcome of the workshop and submit the same to MOEF & CC within a period of 3 months i.e. by the end of October 2014. It was also noted that the term 'Human-Wildlife Conflict' has been appropriately replaced by 'Human-Wildlife Interactions'. The IGF (WL), MOEF&CC said that human-wildlife interactions is a most talked about and a priority subject for the Ministry. Occasionally, this is being deliberated upon and only the successful conduct of the workshop will not



serve the purpose. In response, the Member Secretary and Chairman, TRAC assured that workshop proceedings would incorporate the best available information on each type of conflict and would include the Standard Operating Protocol (SOP) for key species on conflict.

- III. Renewal of International Memorandum of Understanding (IMOU) between Colorado State University, Fort Collins, Colorado USA and Wildlife Institute of India (2013-17): The TRAC noted the information that as part of this IMOU, Indian Forest Service Officers undergoing IFS-MCT (Phase III) visited Colorado State University, USA, in August 2014.
- IV. Proposed workshop on Conservation Action Planning for Endemic Turtles in Peninsular India: After deliberations and suggestions by Dr. P.S. Easa, Member-TRAC and Director, In-charge, KFRI, it was agreed that the proposed workshop on "Conservation Action Planning for endemic turtles in Peninsular India" shall be held in 2014 in partnership with the Kerala Forest Research Institute (KFRI), Peechi. Necessary funding support for the same shall be sought from MoEF & CC or DST.
- Enhancement of fellowship at WII for JRF/SRF/TA: Dean, FWS, informed TRAC IV. subsequent to the approval by the WII's Governing Body, the Institute is in the process of implementing revised 'Rules for the award of research fellowships and guidelines for conduct' of Wildlife Institute of India - National Eligibility Test (WII-NET) for selection of Junior Research Fellows (JRFs) and Ph.D. Entrance Test of Saurashtra University in the Discipline of Wildlife Science' during 2014 in the light of guidelines adopted by CSIR'. The 'Rules for the award of research fellowship and guidelines for conduct of Wildlife Institute of India -National Eligibility Test (WII-NET) and Ph.D. Entrance Test of Saurashtra University in the Discipline of Wildlife Science' along with revised syllabus after appropriately incorporating suggestions made by Dr. Reena Mathur and Dr. Priya Davidar, Members, TRAC, was approved by the TRAC and the same is placed as Annexure - I. The TRAC also noted that, as in the past, revised fellowships will be automatically adopted as and when they are revised by the DST, GoI. TRAC also approved one-time age relaxation for WII's internal research scholars those intend to apply for WII-NET 2014 as they have to switch over from existing old norms.
- V. Draft Memorandum of Understanding (MoU) between Smithsonian Conservation Biology Institute (SCBI), USA and Wildlife Institute of India, Dehradun: The TRAC noted the information that the approval from the MoEF & CC for the 'Memorandum of Understanding (MoU) between the Institut National De La Recherche Agronomique (INRA),

- France and the Wildlife Institute of India (WII)' and with that of Smithsonian Conservation Biology Institute is awaited.
- VII. Enhancement of Monthly Stipend to Non-sponsored candidates of M.Sc. Wildlife Science Course: The TRAC noted the information regarding the implementation of enhanced monthly stipend from Rs. 1800/- to Rs. 3000/- for six (6) self-sponsored students of current batch of M.Sc. Wildlife Science Course at WII as approved by the Governing Body.
- VIII. Effect of landscape characteristics on butterfly communities in Dehradun, Uttarakhand: The TRAC noted the information that the response from Uttarakhand State Biodiversity Board for funding the research project is awaited.
- IX. Study on ecology and migratory patterns of Golden Mahseer (Tor putitora) using radio telemetry techniques: The TRAC noted the information that the response from Uttarakhand Forest Department for funding this research study is awaited.
- X. Meeting of CWLWs of north-eastern states to prepare strategies for research in the NE region with funding support from MoEF: The Member Secretary informed TRAC that as and when the meeting of CWLWs of North-Eastern States is organised by the MoEF & CC in the near future, necessary strategies for research in the NE region will be taken up by the Institute with funding support from MoEF & CC in the same meeting.
- XI. Phase-II of the monitoring of re-introduced tigers in Panna Tiger Reserve in collaboration with MPFD and NTCA: The TRAC noted that the Phase-I of project has ended in July 2014 and subsequently the Phase-II will be initiated in collaboration with MPFD and NTCA.
- XII. Annual Work Programme of WII (2014–15): Dean, FWS informed that subsequent to endorsement of Annual Work Programme of WII (2014–15) by the TRAC in its 31<sup>st</sup> Meeting held on 17<sup>th</sup> February 2014 and approved by the Institute's Governing Body in its 62<sup>nd</sup> Meeting held on 12<sup>th</sup> May 2014 TRAC some of the activities (Training and Research) listed in the revised Annual Work Programme at Sl. No. B.5 "WII's Alumni Meet for Ph.D. and M.Sc. Degree Awardees"; B.24 "Training Workshop on Wildlife Health Management for the Field Veterinarians of Uttar Pradesh State"; D.8 "Establishing ecological baselines for long term monitoring of tigers, co-predators and prey species in Dibang Wildlife Sanctuary and its adjoining landscapes in Arunachal Pradesh"; F.55 "Ecology and conservation of sea turtles along the Sindhudurg Coast, Maharashtra"; F.56 "Evaluating ecological status of leopards in Kalesar National Park, Haryana"; F. 57 "The diet of Amur Falcon (Falco amurensis) at an

important stop-over site in Nagaland, India during their southbound migration" and H.10 "Compulsory Course Work for the candidates registering for Ph.D. Program in the FRI University, Dehra Dun and Saurashtra University, Rajkot, WII Centre (2014-15)" were included on the request of respective CWLW of State Forest Departments and other agencies. TRAC endorsed the additional activities conducted and proposed by the Institute in the revised Annual Work Programme of WII for the year 2014–15 subject to the approval of Governing Body.

- XIII. Emeritus Scientist Scheme (ESS) at WII: The Dean, FWS informed TRAC that the WII's Governing Body in its 62<sup>nd</sup> Meeting held on 12<sup>th</sup> May 2014 has approved the implementation of Emeritus Scientist Scheme (ESS) and, subsequently, comprehensive rules and regulations as amended in the light of guidelines adopted by CSIR for implementing the same at WII has been placed to TRAC for necessary approval. The same was approved by the TRAC.
- XIV. Different scientific theme based research work in Tripura State: The TRAC was informed that the DCF (Wildlife), Tripura, vide his letter No. F. 8 (243)/wl-2012/TRAC/50-59 dated 19.05.2014 requested WII to conduct research studies on six select topics in Tripura. Subsequently, faculty members of the Institute were requested to develop research proposals on the assigned theme/topics at the earliest in consultation with PCCF (Wildlife) & CWLW or DCF (Wildlife), Tripura. In response, two research proposals viz 'Ecological status of clouded leopard and sympatric carnivores in Tripura' and 'Ecological status on non-human primates of Tripura' were submitted by WII faculty members to the PCCF(WL) & CWLW, Tripura for funding. Since there was no funding available with Tripura State Forest Department to support the proposed two studies, the Director, Clouded Leopard National Park, O/o PCCF, Tripura, has written to the Inspector General of Forests (WL), MoEF & CC, Govt. of India, requesting to provide necessary funds to conduct the above studies. Further, developments in this regard will be reported to TRAC in its next meeting.

Proposal for 'Strengthening and Modernization of Wildlife Forensic and Conservation Genetics Research Facilities for Conservation of Flagship Species' to the Oil and Natural Gas Corporation (ONGC) under Corporate Social Responsibility (CSR): Member Secretary informed the TRAC that the proposal for 'Strengthening and Modernization of Wildlife Forensic and Conservation Genetics Research Facilities for Conservation of Flagship Species at Wildlife Institute of India' with funding support from the Oil and Natural Gas Corporation (ONGC) under Corporate Social Responsibility (CSR) was discussed during the meeting of the Chief Executives of select Public Sector Undertakings

held on 13<sup>th</sup> August, 2014 at New Delhi. The Institute has also prepared a document 'Partnerships on Conservation' for securing funding under CSR. It was also informed that further developments in this regard will be informed to TRAC in its next meeting.

XVI. Establishment of UNESCO Category 2 Centre on World Natural Heritage Management and Training for the Asia-Pacific Region at Wildlife Institute of India: TRAC appreciated the efforts of the MOEF&CC and WII in setting up UNESCO Category-2 Centre on World Natural Heritage Management and Training for the Asia-Pacific Region at WII.

### Agenda Item No. 3

Proposal for budget revision, no cost extension and time period extension of ongoing research projects

3.1. Evaluation of MHC heterozygosity in isolated tiger population: The TRAC approved a 'No Cost' extension to the project for a period of one year from 04.02.2015 to 03.02.2016 to complete the analysis and submission of final report.

# Agenda Item No. 4 Consideration of new research proposal

Research and management of Rhesus macaque - Human interface in a mosaic 4.1. landscape: Dr. Y. V. Jhala, PI of the project, explained the genesis of the proposal to the TRAC members and highlighted the national importance of the research to address potential solutions for locally abundant wildlife populations that can attain pest proportions. This was followed by a presentation of the proposed research. The TRAC members appreciated the presentation and agreed to the importance of the applied problem solving nature of the research in the national context. The TRAC deliberated whether the study area in and around WII campus could serve as a model that could subsequently be replicated in other regions infested with macaque problem. After much deliberation, it was decided that the study area would serve the purpose as it will be carried out in a mosaic of habitats that included urban, forest, agriculture, and rural areas. Further, the project would benefit from the ownership and involvement of the larger WII's student fraternity. Dr. S. Shivaji, Member TRAC suggested that there may be possibility to develop macaque specific Zona Pellucida vaccines instead of using Porcine Zona Pellucida vaccines for immuno-contraception of macaques. He agreed to provide the contact details of scientists to explore this further. This proposal was discussed at length with Dr. S.K. Khanduri, IG (Wildlife) and representative MoEF & CC and Sh. D. V. S. Khati, Addl. PCCF (WL) & CWLW, Uttrakhand. Both agreed to find funds to support the proposed research project. The Director WII and Member Secretary stressed that the project would only commence once there was clarity and commitment of funding from external sources. The TRAC approved the five year research proposal `in principle' with a budget outlay of Rs 1.20 crores and the PI was advised to explore possibilities of getting external funding for the project from Uttarakhand Forest Department/MoEF & CC.

### Supplementary Agenda Item No. 1

### Reorganization of Wildlife Forensic Cell and Conservation Genetics Laboratory at WII

The TRAC considered the Supplementary Agenda on the reorganization of Wildlife Forensic Cell (WFC) at WII. TRAC noted that activities of the existing 'Wildlife Forensic Cell' have grown manifold in scope and mandate since the period when this was initiated as a project under Indo-US collaborative effort. TRAC was informed that the MoEF & CC has provided some financial support initially to strengthen required infrastructure at WFC. Dean, FWS informed TRAC that so far Institute has received over 2,800 legal cases from various law enforcement agencies for investigation and providing technical reports. TRAC also noted that the Governing Body in its 58th meeting held on 29th March 2012 has approved to charge Rs. 15,000/- per legal case from the concerned agency towards laboratory investigations, sample analysis and the cost for appearance in the court by the technical expert and defend the legal case. It was also approved that no fee shall be charged for the analysis of samples received from Uttarakhand Forest/Wildlife Department, Hon'ble Courts and the Central Bureau of Investigation (CBI). Member Secretary informed that over the years WFC has started making optimal use of molecular biology/DNA based technology. Dr. S. P. Goyal, Scientist-G and Nodal Officer, WFC who was instrumental in development of WFC is due for superannuation on 31.8.2014. Considering the increasing involvement of Molecular/DNA based technology or conservation genetics and the fact that Dr. Goyal is superannuating soon, there is a felt need to reorganize the Wildlife Forensic Cell and Conservation Genetics Laboratory at WII as Wildlife Forensics and Conservation Genetics (WFCG) Cell under Dr. Y.V. Jhala, Scientist 'G" as Nodal Officer, WFCG Cell. Upon superannuation Dr. S.P. Goyal is expected to be associated with WFCG as Emeritus Scientist which has already been approved by the TRAC as well as the Governing Body.

After deliberation, TRAC approved the proposed reorganization of Institute's Wildlife Forensic Cell and Conservation Genetics Laboratory as Wildlife Forensics and Conservation Genetics (WFCG) Cell with suggestions from Chairman TRAC and noted the distribution of responsibilities among existing manpower with a suggestion to incorporate horizontal linkages in organogram at all levels. The revised organogram is placed as Annexure - II. The Member Secretary as well as Chairman, TRAC were of the opinion that it would be appropriate that MoEF&CC; Director, WII and Nodal Officer, WFCG Cell collectively consider the aspect of accreditation of WFCG Cell so as to avoid frequent appearance in the court by technical experts and to find ways for strengthening and smooth function of vital WFCG facility at WII.

### Any other item with permission of Chair

The Dean, FWS informed the TRAC that the Institute conducted its First Alumni Meet of M.Sc. students and Ph.D. scholars who had obtained their degrees from various Universities at WII since its inception. The Alumni Meet was inaugurated by Hon'ble Vice-Chancellor, Saurashtra University on 21<sup>st</sup> August 2014 followed by presentations made by WII-Alumni on 22<sup>nd</sup> August 2014 on select thematic areas. In total, 74 alumni attended the said meet. Dean, FWS also informed that the Institute's X-Internal Annual Research Seminar (IARS) was conducted from 18<sup>th</sup> to 20<sup>th</sup> August 2014 and the XXVIII-Annual Research Seminar (ARS) on 21<sup>st</sup> August 2014 at WII. A brief report on the IARS and ARS is placed as Annexure - III.

Prof. R. Sukumar informed that his tenure of three years as Chairman, TRAC has come to an end and he has thoroughly enjoyed his role as Chairman with active support from other Members. He appreciated the achievements of WII in the last three years in Training, Research and Academic endeavours. He also thanked the Members of TRAC for their valuable contributions made for the smooth functioning of TRAC. The Member Secretary expressed his gratitude to Prof. Sukumar, Chairman, TRAC and non-official members of the TRAC whose 3 year term was coming to end for their active support and contribution in enhancing the quality of training, research and academic activities of the Institute. Member Secretary also wished that Institute will continue to receive guidance and advice by the outgoing Chairman and Members.

The meeting ended with Vote of Thanks to the Chair.



### Rules for the Award of Research Fellowship and Guidelines for conduct of Wildlife Institute of India - National Eligibility Test (WII-NET) & Ph.D. Entrance Test of Saurashtra University in the Discipline of Wildlife Science

### 1. Background

The Government of India established Wildlife Institute of India (WII) at Dehra Dun in 1982 and conferred autonomous status in 1986. WII seeks to create a cadre of trained wildlife managers, wildlife biologists/ecologists and socio-economists and help generate research information on biological, managerial and human aspects of wildlife conservation. The WII's research guided by its "Training, Research and Academic Council (TRAC)" addresses applied and basic research in different ecological and geographic regions of the country. Wildlife Science is a fast developing discipline in India and yet to be recognized as a subject by the University Grants Commission (UGC), Council of Scientific and Industrial Research (CSIR), Indian Council of Agricultural Research (ICAR) & Graduate Aptitude Test in Engineering(GATE) for their National Eligibility Test (NET) for the award of research fellowships. The research demands in this discipline are both academic, applied and management oriented and therefore, essentially field based. Thus, requires appropriate field aptitude and physical fitness to undertake research in arduous field and harsh climatic conditions. The Institute carries out its research projects supported by its Grant-in-aid funds as well funded by other national and international agencies. Institute thus, engages research personnel [Junior Research Fellow (JRF) and Research Associate (RA)]. The norms/guidelines to engage research personnel as developed by CSIR are helpful to a great extent and have been used as the basis for selection of researchers in the discipline of Wildlife Science and award of research fellowship(s) by Wildlife Institute of India. In order to attract talented students, WII intends to further develop better ways for awarding fellowships to researchers at WII.

To achieve this and to promote WII as the 'Centre of Academic Excellence' in the field of Wildlife Science, the Institute proposes to conduct WII-NET annually in the field of "Wildlife Science" for the purpose of award of Junior Research Fellowship(s). The WII-NET qualified candidate, who subsequently qualifies the interview conducted by the Institute, will be eligible for the award of Junior Research Fellowship to carry out research by joining a specific assigned project. The WII-NET qualified candidates shall be considered in equivalence with UGC/CSIR/ICAR NET qualified candidates for Junior Research Fellowship. In addition, GATE qualified candidates for the award of JRFship in the discipline 'Ecology and Evolution' shall also be considered in equivalence to WII-NET qualified candidates.

These guidelines are relevant to the award of JRFs/RAs at the Wildlife Institute of India and to encourage researchers (JRFs/SRFs) to pursue higher education by way of Ph.D. degree. Presently, WII's researchers register for Ph.D. degree in 'Wildlife Science' with the Saurashtra University, Rajkot (Gujarat) or with FRI University, Dehradun for Ph.D. in "Forestry" or allied subjects.

### 2. Rules for the award of Junior Research fellowship (JRF) at WII

### 2.1. Eligibility

- 2.1.1 Essential Qualification: A candidate seeking selection as JRF must possess M.Sc. (Botany/Zoology/Forestry/Statistics/Life Science/Experimental Biology/Environmental Sciences/Environmental Management/Geo-informatics/Biological Sciences/Wildlife Science or M.V.Sc. or M.Sc. Agriculture or M.A. (Sociology/Economics/Mass Communication/Anthropology and Psychology) degree from a recognized University with a minimum of 60% aggregate marks.
- 2.1.2 Desirable Qualifications: The desirable qualifications will be specifically determined by the individual project needs.
- 2.2 Age: The candidate shall not be more than 28 years of age as on the last date of receiving applications online for appearing in WII's National Eligibility Test (WII-NET) for the award of Junior Research Fellowship (JRF) at WII. The upper age limit may be relaxed up to 5 years in the case of candidates belonging to SC/ST/OBC/Women and Physically Challenged applicants.

### 2.3 Selection Procedure

- a) Announcement of JRF positions will be made in the National Daily Newspaper (English) and WII's website well in advance.
- b) Qualified candidates of UGC/CSIR/ICAR/WII-NET for the award of JRFship meeting the essential qualification as given in para 2.1.1 shall be eligible to appear for an interview conducted by the Institute as per the advertised positions. In addition, meeting the essential qualification as given in para 2.1.1, GATE qualified candidates for JRFship in discipline 'Ecology and Evolution' are also eligible to appear for the interview.
- c) An 'Expert Committee' recommended by the Dean, FWS and approved by the Director, WII, for interviewing the NET qualified candidates will consist of the Dean, Faculty of Wildlife Science; External Subject Expert (1); the Research Coordinator; two senior Faculty Members (Scientist-E and above); and concerned P.I. of the Project.
- d) During the interview, the Committee should test the candidate for his/her knowledge of the subject, scientific temperament, aptitude for wildlife research, creative ability and interest. The interview will be of 100 Marks in total. The final selection of the candidate for JRFs will be based on the marks obtained during the Interview.
- e) Candidates are expected to join within 30 days from the date of issue of the fellowship offer, failing which the offer may be cancelled. However, in exceptional circumstances the Dean, FWS may grant an extension of maximum one month to the deserving candidate.

### 2.4 Fellowship and Tenure of JRF

The JRF shall be entitled to get a monthly fellowship of Rs. 16,000/- consolidated. The fellowship shall be enhanced as per the revisions made by the Dept. of Science & Technology (DST), GOI from time to time. The fellowship amount is exempted from the payment of Income Tax under 10(16) of IT Act, 1961. The tenure of award of JRFship will be as per the requirement of the research project/period advertised.

The JRF in special case may be allowed by the Institute to leave for abroad with fellowship to participate or attend in International Workshop/Conference/Symposium/Meeting or to undergo a training programme for a period not exceeding three months during the tenure of award of Junior Research Fellowship, on the recommendations of the supervisor/concerned faculty and approval of Dean, FWS.

### 2.5 Up-gradation of Junior Research Fellow (JRF) to Senior Research Fellow (SRF)

On completion of two years of tenure, a Junior Research Fellow may apply for an up-gradation of research fellowship as Senior Research Fellow with enhanced fellowship of Rs. 18,000/- per month. The fellowship tenure of a JRF can be extended for further period(s) on the recommendation of the PI of the research project adjudged on the basis of the work/achievements made by the researcher in the project and with approval of the Dean, FWS. However, for fellowship up-gradation of a JRF to SRF, application of the JRF duly forwarded by the supervisor(s) will be evaluated by an Expert Committee referred as the 'Research Fellow Performance Assessment Committee – RFPAC' consisting of the Dean, FWS as Chairman; two senior WII-faculty as Members; Research Coordinator as Member Convener and PI/Co-PI of the project, as Special Invitee. The recommendations of the RFPAC would need to be considered and approved by the Director, WII. Detailed progress reports duly supported by reprints of publications along with the recommendations of the RFPAC are to be forwarded by the Dean, Faculty of Wildlife Science to the Director for approval for issuing extension/up-gradation order.

# 3. Rules for the award of fellowship as Research Associate (RA)

### 3.1 Scope and Objective

This scheme envisages providing opportunities and support to outstanding research workers to do research work independently at post-doctoral level. The main objective is to utilize the skills and competence of post-doctoral fellow for research at higher level of scholarship. The fellowship will be tenable at WII, Dehradun, and also at the sites of field based research projects.

### 3.2 Eligibility

The award of Research Associateship at WII intends to engage research scholars below the age of 40 years with a doctorate (Ph.D.) degree in Zoology/Botany/Wildlife Science/Environmental Science/Forestry/ Experimental Biology/Biological Science/Life Science and Social Science relevant to studies in human dimensions aspect of wildlife management, have published research work to their credit and have already shown evidence of independent research work. Age limit is relaxable by five years for candidates belonging to SC/ST/OBC/Women and Physically Challenged applicants.

### 3.3 Selection Procedure:

- Announcement of RA positions for 'walk-in-interview' will be made in the National Daily Newspaper (English) and WII's website at least one month prior to the date of conducting the 'walk-in-interview'.
- Display the Screening of applications will be done by a 'Screening Committee' consisting of the PI of the Project/Nodal Officer/Cell In-charge/concerned Head of Department, Research Coordinator, and two senior faculty members (Scientist E and above) of the Institute. This Screening Committee would be proposed by the Dean, Faculty of Wildlife Science and approved by the Director, WII. The following criteria will be used for candidates application evaluation:

- During the interview, the Committee should test the candidate for his/her knowledge of the subject, scientific temperament, aptitude for wildlife research, creative ability and interest. The interview will be of 50 Marks in total. Final selection of the candidate will be based on the total marks obtained from screening of application as per the criteria mentioned above in point 'b' (50 Marks) plus the Interview marks (50 marks). List of selected and wait-listed candidates based on merit will be prepared subject to availability of vacancies.
- e) Candidates are expected to join within 30 days from the date of issue of the fellowship offer, failing which the offer may be cancelled. However, in exceptional circumstances the Dean, FWS may grant an extension of maximum one month to the deserving candidate.
- 3.4 Fellowship and Tenure of Research Associates (RAs): The Research Associateship will be awarded in three categories carrying the following consolidated emoluments:

RA-I Rs. 22,000/- per month, consolidated.

RA-II Rs. 23,000/- per month, consolidated.

RA-III Rs. 24,000/- per month, consolidated.

Selected Research Associate may be fixed at any one of the above three categories, depending upon the qualifications and experience. The Selection Committee may decide the level in which a particular Associate should be placed. The fellowship amount to RAs shall be enhanced as per the revision by DST, GOI from time to time and shall be exempted from the payment of Income Tax under 10(16) of IT Act, 1961. A 'Term of Reference' (ToR) highlighting description of expected research work, contributions to be made, responsibilities assigned and envisaged outputs from the selected RA will be prepared by the concerned PI/supervisor at the time of joining and the said ToR will be signed by the RA and countersigned by the supervisor(s) and will subsequently be approved by the Dean, FWS.

The Research Associateship will be tenable initially for a period of three years extendable for another term not exceeding two years. The fellowship will take effect from the date of joining by the RA at WII.

# 3.5 Conditions of award of fellowship as Research Associate

- a) The Research Associate (RA) will do whole time research work and will not enjoy any other part time employment during the tenure of the Associateship. However, his/her services could be utilized by the Institute for teaching purpose provided it will not affect the research programme and he/she should not accept any extra remuneration for this purpose.
- b) The Research Associate of the Institute should submit annual progress report of his/her research work, through the Supervisor/Faculty with whom he/she is associated. The Research Associate shall submit a comprehensive report to the Institute before the expiry of Associateship free of cost and a copy of the published work (if any), and an abstract in about 500 words of the research work done during the fellowship tenure, through the concerned supervisor/ faculty.
- c) If the Research Associate wishes to leave the fellowship before the end of tenure, a prior approval of the Dean, FWS must be obtained. The RA would also obtain prior approval of Dean, FWS for appearing at any examination/interview by any Institute/Organization/
- d) If the Dean, FWS is not satisfied either with the progress of the research work or the conduct of the Research Associate, the Institute may terminate the fellowship at any time without any notice and assigning any reason, thereof.
- e) The award of fellowship as Research Associate does not imply any assistance or guarantee for subsequent appointment in WII to the beneficiary.
- f) The Research Associate may avail leave for a maximum period of thirty days in a year in addition to general holidays as applicable, on the recommendation of supervising faculty and approval by the Dean, FWS. Women awardees would be eligible for maternity leave at full rates for a period, not exceeding three months only, once during the tenure of the award.
  - The Research Associate in special case may be allowed by the Institute to leave for abroad with fellowship to participate or attend in International Workshop/Conference/ Symposium/ Meeting or to undergo training programme for a period not exceeding three months during the tenure of award of Research Associateship, on the recommendations of the supervisor/concerned faculty and approval of Dean, FWS. This period will be counted as without fellowship towards the tenure of Research Associateship.
- g) A Research Associate will be eligible to claim TA/DA for the tour undertaken by him/her only in connection with his/her approved research programmes/or presentation of research results in a conference/seminar/symposium, etc. during the fellowship tenure. The basis for calculating TA/DA will be the actual monthly fellowship of the RA, which shall be considered equivalent to the Basic Pay as admissible to the employees of the



Institute. No TA/DA shall be admissible for stay at the field station and travel within the defined study area. Leave travel concession (LTC) will not be admissible during the fellowship tenure.

h) Due authorship will be given to RA who has contributed to research papers and patents. The PI of the Project/concerned faculty supervisor will be responsible for a fair and just authorship order. In case of any dispute, the Dean, FWS will be responsible to resolve it amicably.

### 3.6 House Rent Allowance

The Research Associate may be allowed hostel accommodation. In case of non-availability of the hostel accommodation, House Rent Allowance (HRA) will be allowed as per the rules of the Institute. The basis for calculating HRA will be the actual monthly fellowship of the Research Associate and the fellowship amount will be taken as Basic pay.

### 3.7 Medical Facilities

Health facilities will be available to the Research Associates on the basis as that for other Junior/Senior Research Fellows of the Institute.

- Guidelines for conduct of WII's National Eligibility Test (WII-NET) for the award of Junior Research Fellowship (JRF)
  - 4.1 An 'online' National Eligibility Test (NET) of the Wildlife Institute of India (WII-NET) for the award of Junior Research Fellowship (JRF) at WII will be conducted once every year preferably during the period of July-September. Announcement for the same will be made in the National Daily Newspaper (English) and WII's website well in advance.
  - 4.2 Eligible candidates as per the advertised essential qualification shall appear for the WII-NET on a specified date at the Centre, allotted as per the Admit Card issued.
  - 4.3 Qualifying the WII-NET would not automatically imply the award of fellowship to the candidate. However, all candidates who qualify WII-NET will be eligible for applying for an interview (which will be conducted thrice a year) at WII or as and when advertised for the vacant positions of JRF under various research projects.
  - 4.4 The upper age limit for (JRF/SRF) engaged at WII under various ongoing research projects, who wish to appear in WII-NET, 2014, shall be not more than 35 years as on the stipulated last date of receiving applications online in response to WII's advertisement. NET qualified WII's researchers shall be entitled to get a monthly fellowship of Rs. 16,000/- consolidated for Junior Research Fellowship and monthly fellowship of Rs. 18,000/- consolidated for the award of Senior Research Fellowship.
  - 4.5. The research fellowship (JRF/SRF/RA) shall be enhanced as per the revisions made by the Dept. of Science & Technology (DST), GOI from time to time. The fellowship amount is also exempted from the payment of Income Tax under 10(16) of IT Act, 1961.
  - **4.6.** The tenure of award of JRFship will be as per the requirement of the research project/period advertised.
  - 4.7. The WII-NET score secured by the candidate shall be calculated by following steps:
    - a. Determine the rank of the candidate. This ranking indicates how well candidate has performed in WII-NET relative to all of the other test-takers. The person who performed the best receives a ranking of 1, the second best receives a ranking of 2, and so on.
    - b. Determine the total number of candidates appearing in WII-NET.
    - **c.** Insert the information gathered from the first two steps into the formula:  $P = ((T-R) / R) \times 100$ , where P = Percentile, T = Total number of candidates, and R = All India Rank. For example, if a candidate obtains All India Rank 700 and the total number of candidates appeared were 3,000, this information would be used into the formula to get:  $P = ((3,000-700) / 3,000) \times 100$
    - **d.** Solve the equation. Using example from the previous step would give:  $P = (3,000 700) / 3,000) \times 100 --> P = (2,300 / 3,000) \times 100 --> P = 0.766 \times 100 --> P = 76.6%$
    - e. The cutoff for WII-NET for the advertised positions of JRFs shall be 60% and above.
- Guidelines for conduct of Ph.D. Entrance Test of Saurashtra University in the Discipline of 'Wildlife Science'

Candidate qualifying WII–NET shall make him/her eligible for admission in Ph.D. Program of Saurashtra University in the discipline of 'Wildlife Science'. However, admission to Ph.D. Programme in Wildlife Science will be regulated as per the provisions of Ph.D. Ordinance of the Saurashtra University, Rajkot. Qualified candidates of UGC/CSIR (JRF) Examination/SLET/NET/GATE or who are the teacher fellowship holders/M.Phil. Degree holders shall be exempted from the Entrance Test for Ph.D. However, they would be required to go through the process of Research Degree Committee (RDC).

Selected candidates shall prepare the synopsis of their Ph.D. proposal and defend the same before the RDC of Saurashtra University in its meeting tentatively to be held sometime in July-September every year at WII. The Ph.D. proposal should include the title (research topic), name of the Ph.D. Guide from Wildlife Institute of India, Introduction, Literature Review, Study Area, Methodology, Data Analysis, Expected Outcome, Work Plan and References.

### 5.1 Eligibility for Ph.D. Entrance Test at Saurashtra University

Candidate must have obtained a Post-graduate degree with 55% aggregate marks in Life Sciences (Botany/Zoology/Forestry/Statistics/Experimental Biology/Environmental Science/Biological Science/Wildlife Science/Agriculture/M.V.Sc.) and 5% relaxation in marks will be given to the candidates belonging to the SC/ST and OBC category. Candidate appearing in the final examination of the Post Graduate Degree, shall also be eligible to apply for the Entrance Test, but their Entrance Test result will be validated only after their final Post Graduate Degree Examination Result in the same academic term/semester.

### 5.2 Age Limit for Ph. D. Entrance Test at Saurashtra University

There is no age limit for the candidates seeking Ph.D. Registration in the Saurashtra University.

# 6. Pattern of Question Paper and Marking Scheme for WII-NET and Ph.D. Entrance Test of Saurashtra University

WII-NET and the Ph.D. Entrance Test of Saurashtra University in the discipline of 'Wildlife Science' would be conducted on the following components;

WII-NET Paper would contain only 'Multiple Choice Questions (MCQ)' carrying equal marks. These questions shall be objective in nature and each will have four answers, out of which the candidate has to mark the correct answer. There will be negative marking for wrong answer to

the extent of one-forth (1/4) of the marks allotted to the question. The duration of the WII-NET is three hours.

### 7. Design of Questions

The questions in a paper may be designed to test the 'Knowledge' and 'Understanding' on the basis of *Recall* abilities (expected to be able to obtain the answer from his/her memory of the subject), *Comprehension* (candidates ability to draw simple conclusions from fundamental ideas), *Application* (candidate is expected to apply his/her knowledge through logical reasoning) and testing skill *Analysis and Synthesis* abilities (candidate is presented with data, diagrams, images etc.), that require analysis before a question to be answered. A synthesis question might require the candidate to compare two or more pieces of information.

### 8. Mode and frequency of WII-NET/Ph.D. Entrance Test

The WII–NET/Ph.D. Entrance Test will be conducted 'online' once a year sometime during the month of July-September. Announcement for the same will be made in the National Daily Newspaper (English) and WII's website well in advance.

### 9. Validity period of WII-NET/Ph.D. Entrance Test

The validity of WII–NET will be for a period of two years from the date of declaration of results. However, the time limit of validity period is not applicable in case of Ph.D. Entrance Test of Saurashtra University.

### 10. Model Question

1.	The engagement is for an occasional nature of work and is purely on temporary basis for a period of from to However, the same can be extended by the Institute, depending upon the exigencies of work at its sole discretion.
2.	Award of fellowship will be subject to his/her being found medically fit. For this purpose he/she is required to submit a medical fitness certificate issued by a Registered Medical Practitioner at the time of his/her joining.
3.	The award of fellowship does not imply to the awardee any assurance of guarantee for subsequent employment in the institute. The engagement is purely occasional and would not entitle a research fellow to any regular employment in the services of the Institute.
4.	During the term of engagement, the fellowship will be governed by the office orders, rules and regulations of the Institute passed from time to time as are/or will be made applicable to research personnel from time to time.
5.	During the term of engagement, he/she will be paid the fellowship of per month. The fellowship as shown above is consolidated and all
	inclusive. He/She will not be entitled to any other allowances, bonus, LTC and/or retirement benefits as are admissible to regular employee of the Institute.
6.	Even during the said period of engagement fromto, the fellowship can be discontinued without giving any notice and without assigning any reason thereof.
7.	On the expiry of the said period or at the end of the extended period, the engagement will automatically come to an end.
8.	At the time of joining the Institute he/she will have to submit two financial sureties from responsible persons (viz. Group 'A' and 'B' employees of Central Government/State Government/Autonomous Institutions under Central/State Government, Universities, etc.) for Rs. 50,000/- (Rupees Fifty Thousand Only) each. Pro-forma for the financial security will be issued by the O/o Research Coordinator subsequent to the joining of research fellow.
9.	The acceptance of engagement will be deemed for an unreserved acceptance of the terms and conditions.

- 10. Travel Rules: A research fellow will be eligible to claim TA/DA for the tour undertaken by him/her only in connection with his/her approved research programmes/or presentation of research results in a conference/seminar/symposium, etc. during the fellowship tenure. The basis for calculating TA/DA will be the actual monthly fellowship, which shall be considered equivalent to the Basic Pay as admissible to the employees of the Institute. No TA/DA shall be admissible for stay at the field station and travel within the defined study area. Leave travel concession (LTC) will not be admissible during the fellowship tenure
- 11. Leave: A research fellow will be entitled to avail eight days (08) casual leaves per year during the fellowship tenure with approval from the concerned supervisor. No carrying over of the leave to the next year is permitted. Dean, FWS under special circumstances may consider sanction of leave without fellowship. In case a research personnel proceeds on leave before termination of fellowship, he/she must join back duty before the expiry of tenure, failing which the tenure will be deemed to have terminated with effect from the date
- 12. A research personnel in special case may be allowed by the Institute to leave for abroad with fellowship to participate or attend in International Workshop/Conference/Symposium/ Meeting or to undergo training programme for a period not exceeding three months during the fellowship tenure, on the recommendations of the supervisor/concerned faculty and
- 13. Accommodation/HRA: The research fellow may be allowed hostel accommodation. In case of non-availability of the hostel accommodation, House Rent Allowance (HRA) will be allowed as per the rules of the Institute. The basis for calculating HRA will be the actual monthly fellowship of the research fellow and the same will be taken as Basic pay.

For Hostel facilities at WII, researcher is required to deposit Refundable Caution Money of Rs. 3,000/- and Hostel Mess Advance of Rs 3,000/- at the time of occupying hostel room.

- 14. DA, CCA, HCA, etc.: He/She will not be entitled to these allowances.
- 15. Medical Benefits: Research personnel will be provided medical benefits as per the rules of the Institute. This will be limited to the research personnel only and not for his/her family members/dependents. The Institute will obtain Life/Personal Accident insurance coverage for researcher, as decided from time to time.
- 16. Books and Book Allowance: For making aware the Research Personnel with the up-todate development of the scientific research, the Institute will make available field guides, technique manual, etc. from Institute library. In addition, a research personnel can avail Book Allowance of Rs. 2,500/- once during the fellowship tenure to purchase books, periodicals, research publications, etc. pertaining to the concerned research project, on recommendation of the Supervising Faculty/PI and necessary budgetary provisions are made in the project budget under contingency. The research personnel may use their rational freedom for using book allowance but supervisor shall ensure proper utilization of the same. If warranted, the supervisor will recommend disallowing of any unjustified

purchases and in such cases, the book amount will be recovered from research personnel. However, since the books, etc. so purchased will be the property of the Institute, it will be the sole responsibility of the research personnel to maintain proper account of the books and deposition of the same in the Institute's Library after completion of the research project. Respective supervising faculty/PI of the project will ensure the stock entry of books purchased in the project and its subsequent return.

- 17. Field Equipment: For research purpose the institute will issue following equipment/kits to each research fellow as per the field conditions of the research project and subject to having budgetary provisions. These items will be the Institute's property: (a) Camera with lenses and tripod; (b) Binoculars; (c) Tent; (d) Compass; (e) Calculator; (f) Thermometer (Max. & Min.); (g) Sleeping bag; (h) Ruck-sack; (i) Torch; and (j) Raincoat. The supervising faculty will ensure return of the permanent items at the time of conclusion of the project.
- 18. Field Dress Allowance: Research personnel shall be allowed to avail Field Dress Allowance annually to procure field shoes and uniform from the project fund. The amount not exceeding Rs. 2,500/- may be sanctioned for field dress/uniform (Olive Green) to research personnel.
- 19. Publication/Patent: The results of research work will be encouraged to publish in peer-reviewed journals as well as other popular forms of scientific documentation at the discretion of the Principal Investigator. Due authorship will be given to all researchers and other team members, who have contributed to research papers and patents. The PI of the project will be responsible for a fair and just authorship order. In case of any dispute, the Dean, FWS will be responsible to resolve it amicably. Due acknowledgement will be given to all funding agencies in all publications arising out of research work conducted at WII. The right to commercial exploitation of the results and patent arising out of the investigation will, however, rest exclusively with WII. In case of projects funded by other agencies or collaborative research project(s), the commercial exploitation of the results and patent arising out of the research work will be worked out as per the Memorandum of Understanding (MoU) signed between the collaborating parties or as per the guidelines of the concerned funding agency.
- 20. Identity Card: Institute will issue an identity card to each Research personnel. Research personnel will be able to obtain identity card from the Administrative Section before leaving for field station. For this purpose, each research personnel should furnish requisite information to the Administrative Section.
- 21. Transport Facility: While drawing the research project, the concerned supervising faculty will visualize the need for the transport for the project i.e. jeep, motorcycle, bicycle and make requisite necessary provisions in the budget. Both for POL and its maintenance and in the event of having jeep/motor cycle, the researcher will be required to maintain logbook, which will be, scrutinized by the concerned supervising faculty and WII Finance Section as and when required. Purchase of vehicles, however, will require further approval from the Governing Body.



- 22. Support Personnel: The Institute allows hiring Field Assistant(s) and Driver(s) locally at the field research site as provisioned in the research project duly approved by the TRAC. The wages for such hired support personnel will be in accordance with the minimum rates as approved by the Labour Commissioner of the concerned state(s) and as amended from time to time. These support personnel will be purely on temporary/casual basis and will have no claim for permanent/regular position at WII.
- 23. Obligations to Other Agencies: Research personnel engaged by the Institute while they have been permitted to avail their fellowship directly from DST/CSIR/UGC, etc. based on qualifying the corresponding National Eligibility Test are obliged to abide by the terms and conditions of such agency in addition to the general terms and conditions of award of fellowship by the Institute.
- 24. The following are the responsibilities that a research personnel is expected to meet under the fellowship grants:
  - a. He/she must be a full time research worker and submit him/herself to the discipline regulation of the institute in which he/she is working. The supervisor may ensure regular attendance of the research personnel by keeping an attendance register.
  - b. In case, of the research personnel desiring to appear for any competitive examination, he/she must inform the Director, WII in writing and obtain written approval before applying. He/she should submit his/her application through the concerned Principal Investigator (PI) and Dean, FWS.
  - c. Each researcher should submit a detailed annual report on the progress of his/her work to his/her supervisor. The project supervisor/investigator shall submit a copy of the progress report to the Office of the Research Coordinator. Once a research fellow accepts the fellowship and joins the Institute, it is obligatory for him/her to continue the fellowship for the normal tenure.
- d. No research personnel shall discontinue his/her fellowship without the prior approval of the concerned supervisor/investigator of the project and the Director, WII. In case, he/she wants to discontinue, his/her fellowship prior to the completion of the tenure or the attainment of original objective of the research, he/she must submit his/her resignation to the Director, WII through his/her project supervisor/investigator at least one month in advance indicating specific reasons for not continuing the fellowship for the full term. In case he/she leaves the fellowship without prior approval of the Director, WII, he/she will be liable to make such refund as may be decided by the Director, WII. The fellowship shall cease from the date stipulated by the Director, WII while accepting the resignation.
- e. Before the termination or resignation of the fellowship, a researcher must furnish a detailed report of the research work done during the entire tenure through the supervisor/investigator to the Director, WII.
- f. Research personnel may apply to register for the award of Ph.D. degree in any University provided the Ph.D. work to be undertaken does not interfere with the research work assigned to the awardee. The Institute would normally encourage research

- personnel to register themselves for Ph.D. registration. A copy of the Ph.D. thesis shall be deposited with the Library of the institute.
- g. The Fellowship amount payable to research personnel is exempted from the payment of the Income Tax under 10(16) of IT Act, 1961.



# A brief report on the X Internal Annual Research Seminar (IARS) and XXVIII Annual Research Seminar (ARS) of WII

The X Internal Annual Research Seminar (IARS) was conducted at WII from 18th to 20th August 2014. The IARS was chaired by Shri Vinod Rishi, Former, ADG(WL), MoEF, Govt. of India, New Delhi, During the IARS, a total of 47 presentations were made by research fellows and faculty members of the Institute under three categories (Newly Initiated Research Projects; Ongoing Research Projects and Completed & Near Completion Research Projects) in 10 (Ten) technical sessions viz., Biodiversity and Drivers of Change; Studies on Avifauna; Ecology of Large Mammals and Wildlife Techniques; Conservation Genetics and Bio-informatics; Conservation and Development; Park-People Interface; Species Communities & Landscape Ecology; Large Carnivores and their Prey; Conservation Genetics & Ex-situ Conservation, and Diversity and Distribution of Flora and Fauna. The following were adjudged as the 'five best' oral presentations and the research personnel were awarded book prizes:

The XXVIII Annual Research Seminar (ARS) of the Institute was conducted on 21st August 2014 at WII. Prof. R. Sukumar, Chairman, Training, Research and Academic Council (TRAC), chaired the ARS. A total of 12 presentations were made by the faculty members of WII showcasing the outcome of their specific research studies conducted during last 5 year or so in four technical session viz., Ecological Studies; Conservation and Development; Long-term Research on Large Mammals and Re-introduction, and Forensics in Wildlife Conservation and Veterinary Interventions.

About 350 delegates attended the ARS that included the Principal Chief Conservators of Forests, Chief Wildlife Wardens and other senior officials representing State Forest Departments, delegates representing NGOs, scientists, wildlife experts, faculty members, researchers, M.Sc. students of WII and IFS probationers from IGNFA.

In the concluding session, comments on the ARS were made, the summary of which is given below:

Dr. Sandeep Sharma, former WII Alumni commented that WII has made tremendous progress in the field of conservation genetics. He complimented the enthusiasm of the presenters and noted that WII presentations stand out on two respects: healthy discussions and constructive criticism, which is unheard of in other Institutes and that this helps managers and practitioners to improve their decisions and management.

Dr. Kavita Isvaran, former WII Alumni expressed her happiness at the diversity of the talks presented at the ARS and that this was an eye opening experience to the research conducted at the Institute.

Dr. Sukumar, Chairman, TRAC expressed his regret for not being able to be present during the IARS. He extended his gratitude to Mr. Vinod Rishi for taking up the responsibility of chairing the IARS. He mentioned that he was happy that the faculty has provided a history of the breadth of projects taken up by the Institute during the ARS. He felt that even though he had been the chairman of the TRAC committee for the past three years, it had been an eye opener and he appreciated the breadth of research conducted at WII. He remarked that the large carnivore presenters ensured that they made a mark. He was especially happy that conceptual issues are being addressed in the Institute, referring to concepts like bird diversity in Himalayas presented by Dr. Dhananjai Mohan. He commented that there is a lot of good information generated on species distribution, on a variety of different taxa and could eventually contribute to insights on biogeography, which is a fairly new and emerging discipline in ecology. He had a couple of comments regarding the Dean's presentation on the overview of research carried out at WII. He said that he agreed with Dr. P. K. Mathur's comment about dwindling Grant-In-Aid to the research Institute; and that even though the quanta of fund might have increased, only a small percentage is available for research and the onus is now on the institute to acquire external funds. He said that this is also apparent, as several faculty members have approached and achieved external funding from CSIR, DST and other funding agencies. He remarked that he is also pleased to see landscape level studies being attempted, which are the future of India. He went on to comment that even though tiger conservation did not start off as a landscape level study and started at PA level, elephant conservation was always taken up at a landscape scale, but he is happy to note that tiger conservation has also reached the landscape level conservation. He expressed that it is important to contribute and merge the science of landscape level planning, ecosystem services, communities and livelihoods in a holistic manner and then take it up to the policy makers. He informed that he had completed three years as the Chairman of TRAC, WII and that 22 Aug, 2014 would be his last meeting as head of the TRAC. He had three messages to the researchers 1) Pay attention to detail in anything that you do, whether its planning, execution, analysis or writing; 2) Ensure quality research and you will be able to make a mark; and 3) Think differently, do not accept established paradigm just because it seems obvious to everybody since science evolves only through paradigm shifts. He also congratulated Dr. V. B. Mathur on his first ARS as Director, WII.

The Director thanked Dr. Sukumar for his comments and reminisced about a comment that Dr. Sukumar made three years ago when he took over as Chairman of the TRAC. He had said that he would like to see a shift in the direction of research addressed in the Institute from dealing with empirical issues to conceptual issues and is happy that he could observe that change. He emphasised on how the Institute is also moving from a PA-based approach to a landscape level approach which was highlighted in the Dean's presentation and also represented in the awards given to the best presenters during IARS. He remarked that a change in ARS structure was attempted for the first time and is happy to have received good feedback, where people have appreciated to have been able to know the research being carried out at WII for the past five years or so. He also mentioned that this is only a part of the story and would be complete after hearing from the alumni the next day regarding what they are doing. The alumni after having passed out from WII have been actively contributing to science and have attained specialization in their fields and he looked forward to hearing some interesting things the following day.

Irregularities in award of M.Sc. Degree(s) from Saurashtra University by WII, Dehradun

As per UGC circular No. F.9-8/2008 (CPP-I) dated 16.4.2009 regarding territorial jurisdiction of the State Universities, all the state governments were clearly instructed to stop their State Universities (Public as well as Private) from operations beyond the territorial jurisdiction of the State in any manner either in the form of off-campus/study centre/affiliated college and the centres operating through franchises in view of the observations in this regard in the case of Prof. Yash Pal and State of Chhattisgarh by the Hon'ble Supreme Court of India. A policy in this regard was also notified by UGC in June 2013 which was required to be followed by all universities/institutions including Open and Distance Learning Institutions wherein it was again stated that a University established or incorporated by or under a State Act should operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the state of its location.

It was, however, noticed in audit that WII initiated M.Sc. in Wildlife Science (a two year full time course in the form of Choice-based Credit System in four semesters of 24 credits each) in the year 1988 with affiliation from Saurashtra University, Rajkot-Gujarat which is a state university established in May 1967 by Gujarat Act No. 39 of 1965 with administrative headquarters at Rajkot and presently having 272 colleges in Amreli, Jamnagar, Junagadh. Porbandar, Rajkot and Surendra-nagar districts affiliated with the University.

In this connection, following irregularities were noticed in audit: -

- 1. WII-Dehradun had been distributing the 2 years M.Sc. Degree in Wildlife Science which was awarded by Saurashtra University (A State University established in 1967) in contravention of the UGC guidelines in this regard as WII is an independent institute located in Dehradun (Uttarakhand) which is outside the territorial jurisdiction of the Saurashtra University in terms of the UGC guidelines in this regard.
- The university should also adopt the guidelines issued by the UGC and other statutory
  bodies concerned from time to time in respect of conduct of examinations. However, the
  documented procedure adopted by WII in this regard was not furnished to audit.

- As per the status list of approved autonomous colleges under the UGC Scheme on 'Autonomous College' as on 27th November 2018, there is only one autonomous college under Saurashtra University which did not include WII-Dehradun.
- As per information submitted to audit, the affiliation in question with Saurashtra University was also expired in 2017.
- As per the Powers and Functions of the UGC, if any university grants affiliation in respect of any course of study to any college referred to in sub-section (5) of Section 12A in contravention of the provisions of that sub-section, clause (f) or (g) of sub-section (2) of section 5, clause (e) or (f) or (g) of section 26 or fails within a reasonable time to comply with any recommendation made by the commission under section 12 or section 13, the commission, after taking into consideration the cause, if any, shown by the university for such failure or contraventions may withhold from the university, the grants proposed to be made out of the fund of the commission.

This had rendered the award of M.Sc. Degree by Saurashtra University by affiliation of WII-Dehradun as irregular. Therefore, immediate steps may be taken to ensure that the degree conferred by the university to WII students as well as sponsored candidates, if any, would not become void. A confirmation from UGC in this regard may also need to be obtained under intimation to audit.

You may recollect UGC directive with F. No. UGC/DEB/QMC/2013 dated 09 August, 2014, which states under clause II "a University established or incorporated by or under a State Act shall operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location". This clause has been pointed out by the Central Government audit suggesting that our affiliation with Saurashtra University is in violation of UGC directives. To this, your office had responded by sending us a copy of the Saurashtra University Act, 1965. However, this does not explicitly address the UGC directives of 2014.

Kindly provide us a clear explanation if and how our affiliation has been exempted from this directive of UGC or not. An early resolution of this matter would be helpful since the new batch of M.Sc. Wildlife Science with Saurashtra University is likely to commence from July, 2021.



Please note that UGC letter under reference: UGC/DEB/QMC/2013, Date:09-08-2014 is regarding affiliating colleges. Please note that Wildlife institute of India is not affliating college. It is an institution of Research and specialised studies recognized under Act(36) and approval of such type of Institution is governed under Act(37).

Further, Saurashtra University Act 5(4) states as under:

"Any educational institution in the state of Gujarat situated outside the University area or in other territories outside the State may, subject to such conditions and restrictions as the University and the State Government think fit to impose, be admitted to the privileges of the University". A copy of Act 5(4) is enclosed.

The Act of Saurashtra University provides power to recognize institutions beyond territorial jurisdiction of the University under the Act and for affiliation, the University followes Act(34). (A copy of Act (34) is also encolsed).

(g) that due provision will, as far as circumstances may permit, be made for the residence of the Principal and some members of the teaching staff in or near the college or the place provided for the residence of the students;

(h) that the financial resources of the college are such as to make due provision for its continued maintenance and efficient

(i) that the college rules fixing the fees (if any) to be paid by the students have not been so framed as to involve such competition with any existing college in the same neighborhood as would be injurious to the interests of


#### INSPECTION OF COLLEGES AND REPORTS.

- 38. (1) Every affiliated college, recognised institution and approved institution shall furnish Such reports, returns and other information as the Syndicate, after consulting the Academic Council may require to enable it to judge the efficiency of the college or institution.
  - (2) The Syndicate shall cause every such college or institution to be inspected from time to time by one or more competent persons authorised by the Syndicate in this behalf.

#### WITHDRAWAL OF AFFILIATION.

- 39. (1) The rights conferred on a college by affiliation may be withdrawn in whole or in part or modified if the college has failed to carry out any of the provisions (1) of section 34 or the college has failed to observe any of the conditions of its affiliation or the college is conducted in a manner which is prejudicial to the interests of education.
  - (2) A motion for the withdrawal or the modification of such rights shall be initiated only in the Syndicate. The members of the Syndicate who intends to move such a motion shall give notice of it and shall state in writing the grounds on which it is made.

Widlife Institute of India, Dehradun is an autonomous Body under the Ministry of Environment, forest and Climate Change, Government of India.

The Wildlife Institute of India started its M.Sc. (Wildlife Sciences Course) from 1987 and affiliated (Annexure I) with the Saurashra University, Rajkot and the degree was awarded by them at par with UGC norms.

Office of the Director General of Audit Scientific Department, New Delhi has raised an audit Memo dated 18<sup>th</sup> Feb 2019 regarding irregularities in award of M.Sc. Degree(s) from Saurashtra University by this Institute. They have mentioned in the audit memo "all the state governments were clearly instructed to stop their State Universities (Public as well as Private) from operations beyond the territorial jurisdiction of State in any manner either in the form of off-campus/study centre/affiliated college and the centres operating through franchises, in view of the observations in this regard in the case of Prof. Yash Pal and State of Chhattisgarh by the Hon'ble Suprement Court of India". A policy in this regard was also notified by UGC in June 2013 which was required to be followed by all universities/institutions including Open and Distance Learning Institutions where it was again stated that a University established or incorporated by or under a State Act should operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the state of its loclation (Annexure II).

### (b) Saurashtra University, Rajkot.

- (i) "Any educational institution in the state of Gujarat situated outside the university area or in other territories outside the State may, subject to such conditions and restrictions as the University and the State Government think fit to impose, be admitted to the privileges of the University".
- (ii) "The Act of Saurashtra University provided power to recognize institutions beyond territorial jurisdiction of the University under the Act and for affiliation of the University follows Act (34)."

Saurashtra University Rajkot letter dated 15the January 2021 alongwith its inclosure is attached (Annexure III).

You are therefore requested to kindly look into the matter and give your direction, whether this Institute (Central Autonomous Institution) may continue to run M.Sc. courses under Saurashtra University (State University Act) or as per UGC norms.
