1) Provide list of names of contractual personnel engaged in various projects by WII to who fellowships have not been paid for various reasons for any duration, from 1st Nov 2021 to 31st Jan 2022.	Nil
2) Name of projects in which fellowships or monthly emoluments were not paid to contractually engaged personnel for any duration since January 2021.	Nil
3) Were the contractually personnel informed officially on behalf of the institute of the eminent delays?	No information has been sought, only questions asked. Hence, no information is available.
4) Has any faculty employed at WII asked contractual employees under them to quit or resign from the project using a public Whatsapp group which may amount to harassment (from Nov 1, 2021 to Dec 31, 2021)?	
5) Is the so called BH Lab an approved entity in WII which has a social media presence on twitter. Many a times WII has retweeted and shared tweets and comments by this entity. Is this entity legally registered with WII Governing Body? Is the same option available for all faculty?	
6) When as per the new norms of Office Orders where researchers or contractual employees are not allowed to be part of any association or union or group etc unless nominated by the WII Administration, does subscribing to the said BH Lab violate this norm? If not, under what guidelines is this subscription legalized or absolved?
