Subject: **Discontinuation of services of Shri M D Gupta, Section Officer (Admin)**

Ministry of Environment Forest & Climate Change has imposed cut on Grant-in-aid to be released to the WII for the Financial Year 2020-2021 & 2021-2022 also. The demand of Grant-in-aid under salary was Rs. 28 crores which has been reduced to Rs. 18 crores. Two Section Officers one on regular basis Smt Anita Pahwa and one Sh. MD Gupta through M/s Industrial Security and Manpower Services has been engaged. The sanctioned strength of Section Officer is one in Admin Section. As such there is excess deployment of one additional Section Officer, which is not justified. It is therefore proposed that services of Sh. MD Gupta, Section Officer engaged through Security Agency may be discontinued further w.e.f 1.03.2021


