- 5. After due deliberation on the points of the appeal, the following decision is hereby made:
- i. The reply/information provided by the CPIO (RTI) to the applicant is found to be correct. Hence, the appeal is disposed off. If the Appellant is not satisfied with the above decision, he may approach to the Hon'ble Central Information Commission, New Delhi for second appeal.
