The Expert Appraisal Committee (EAC) of MoEF&CC in its meeting held on 24.05.2022 considered the proposal for EC and CRZ clearance for Port, Airport, Power Plant and Township as part of holistic development of Great Nicobar Island.

The EAC has recommended that the project proponent in consultation with Wildlife Institute of India (WII) and A&N FD to submit the following:

1. Crocodile conservation plan as part of the EIA/EMP report and also indicate the timeframe for preparation of the plan.
2. Road map with financial requirement for monitoring leatherback turtle movement in Great Nicobar Island and habitat restoration and nest protection measures at all other nesting sites in A & N Islands for minimum 10 years.
3. Megapode monitoring and conservation plan for minimum 10 years.


