Comments relating to the W.P(c) 7493 of 2022 in Gaurav Kumar Bansal Vs Union of India, in the High Court of New Delhi sought by MoEFCC reg.

Dear Ms. Sabina,

This is with regard to the subject on the W.P(c) 7493 of 2022 in Gaurav Kumar Bansal Vs Union of India, in the High Court of New Delhi for which comments were sought from WII. We studied the writ petition and also examined the case in the literature and we are of the opinion that the three NSAIDs specifically stated (Aceclofenac, Nimedulide, Ketoprofen) be banned for veterinary use in India. It is also to be mentioned here that there are two alternative drugs Meloxicam and Tolfenamic acid in place of the three NSAID stated above that have been found safe to vultures. The ban proposed for the three NSAID drugs will therefore have little or no impact on the availability of drugs for the treatment of livestock in India.

We also agree that any new NSAID being introduced in India should be first tested on raptors specifically vultures for any ill effects before approval.
