

8. That the respondent was required to comply with the order of the Hon'ble Court, but till date no compliance has been made. 

Since common question of law and facts are involved in both these petitions, therefore, the same are being taken up together and decided by this common judgment. In order to maintain clarity, the facts of WPSS No. 1057 of 2016 are taken into consideration.

The Government of India, Department of Environment, Forests & Wildlife, Wildlife Division has taken a conscious decision to create autonomous institutions in place of the existing subordinate office of the department namely the Wildlife Institute of India. The relevant part of the communication dated 11.02.1986 reads as under:-

"I am directed to convey the approval of the Government of India to the following proposals:-

1. Creation of an autonomous institution in place of the existing subordinate office of this department namely, the Wildlife Institute of India."

The attention of this Court was drawn to the Scheme placed on Page No. 196 of the paper book. According to this, the pay scale of Library Assistant was Rs.950-1400 and on promotion to the post of Librarian Group III (1), technician A/V etc. pay scale was Rs.1400-2300. The petitioner was also promoted but he was given pay-scale of Rs.4000-6000. The similarly situate persons as per communication dated 26.09.2013, who were in the pay scale of Rs. 1400-2300 were given pay scale of Rs. 4500-7000.

The Central Government has issued a corrigendum dated 10.02.2015 to the following effect, which reads as under:-

Subject: Merger of Senior Technical Assistant and Technical Assistant in the Directorate of Logistics.

It is evident that principal pay scale of Rs. 1400-2300 was revised to 4500-7000. The petitioner has also placed on record the copy of the C.S.R. dated 02.08.2000. According to this, all those employees who were in the pre-revised scale of Rs. 1350-2200 or Rs. 1400-2300 and had been placed in the revised grade of Rs. 4500-7000 w.e.f. 1.1.96, will be considered for assessment to the next higher grade of Rs. 5500-9000 on completion of combined residency period of 10.5 years rendered in the pre-revised scales of Rs. 1250-2200 or Rs. 1400-2300 before 1.1.96 and in the revised scale of Rs. 4500-7000 w.e.f. 1.1.96.

Mr. Rakesh Thapliyal, Assistant Solicitor General for the Union of India/respondents submits that the respondent-organisation has framed its own Rules on 01.04.2006, on the basis of which, the petitioner was granted pay scale of Rs. 4500-7000. has also been paid the pay-scale of Rs. 4000-6000.

It has not been shown by the respondents-organisation that from where pay scale of Rs.4000-6000 came into existence in the Central Government and the organisations under the Government of India. Autonomous bodies have revised the pay scale of Rs.950-1400 to Rs.1400-2300 and Rs.4500-7000, including C.S.I.R. Similar pay-scale has been paid to the Scientists and Ministerial Staff as is evident from the letter dated 26.09.2013.

It is the case of invidious discrimination. The petitioner should have been treated on the same analogy for granting pay-scale as has been paid to the Scientists and other Ministerial Staff.

Accordingly, the writ petitions are allowed. Impugned orders under challenge are quashed and set aside. The respondents are directed to release the pay-scale of Rs.1400-2300 revised Rs.4500-7000 w.e.f. 2002 with interest @9% per annum with all consequential benefits including benefits towards A.C.P.

Pending application, if any, stands disposed of accordingly.
