Subject: Audit of the accounts of WII, Dehradun for the year 2016-18.

Over-payment of Rs. 12.24 lakh towards Ad-hoc Bonus (Non-productivity linked bonus)

Every year, Ministry of Finance (MoF) issue orders for payment of Non-productivity linked Adhoc bonus for the years to the Central Govt. employees in Group 'C' and 'D' and all non-gazetted employees in Group 'B', who are not covered by any Productivity Linked Bonus Scheme. These orders were then endorsed/extended for payment to the eligible employees of the Autonomous Bodies/Institutes till 2014-15. However, the orders for payment of ad-hoc bonus for the year 2015-16, 2016-17 and 2017-18 were not extended to the employees working Autonomous Bodies/Institutes by the MoF.

Scrutiny of the cash-book and allied record/vouchers revealed that WII had made payments of Rs. 6.16 lakh and Rs. 6.08 lakh towards Non-productivity linked bonus for the years 2015-16 and 2016-17 respectively to its regular as well as contractual employees despite no authority to make these payments, as the MoF orders dated 2.10.2016 and 19.09.2017 for grant of bonus for the year 2015-16 and 2016-17 respectively were not endorsed for application to eligible employees of the autonomous institutions as was done till 2014-15.

Thus, the undue payment of Rs. 12.24 lakh made to these employees for the period from 2015-16 to 2016-17 beyond the authority needs to be recovered immediately and compliance in this regard would be shown to audit.
