All of a sudden, a list containing LIST OF ELIGIBLE candidates has been published without telling us as to why we were rejected. In fact no scope for rectifying any plausible mistake was given to us. UPSC/NDA/NTA EACH and EVERY agency that is TRANSPARENT gives timeframe to candidates to rectify any mistake done while application but WII recruitment seems like a total sham. It seemed like WII was trying to create a pool of only certain tailored candidature. Agencies take application fees to check files and ask candidates for missing documents etc. But, WII took money to do nothing. IT is hurting us because all new ELIGIBLE RECRUITS will be feeding off OUR PUBLIC MONEY. We already know how previous recruitments have occurred in WII and it is high time that such internal preferences are done away with.
