**Whereas OM No A-65061(55)/53/2023-GroupbA-CGA)/(13006)478 dated 16th May 2023 states that, since very few officers submits their Annual Medical Examination reports. So in order to ensure the adherence, all the officers above 40 years of age needs to undergo Annual Medical Examination. Please refer to Annexure 3.**

Through D O F. no. 712/170/HRD/WFI/19 dated 19/01/2020, Group B & C Officials are also accommodated for Annual Medical Examination in order to Timely detection of any diseases and improving the general Medical Health of the Departmental Officials and would in turn contribute towards enhancing their performance. **OFFICE MEMORANDUM**

**Subject:- Introduction of Annual Medical Examination for the Group 'A' officers of Central Civil Services of age 40 years and above.**

The undersigned is directed to say that a scheme of Annual Medical Check-up is already operating in respect of All India Service officers. This Department had taken up the issue of covering Group 'A' officers of Central Civil Services/posts for Annual Medical Check-up in consultation with the Ministry of Health and Family Welfare and the Ministry of Finance (Department of Expenditure). It has now been decided that **Group 'A' officers of Central Civil Services/Posts of and above the age of 40 years** will be covered by the Annual Medical Check- up scheme. The following package rates for the above purpose have been approved:-

- (i) Annual Medical Examination of Men officers- Rs. 2000/-  
(Rupees Two Thousand only)
- (ii) Annual Medical Examination of Women officers- Rs. 2200/-  
(Rupees Two Thousand and Two Hundred only)


2. The regime of medical tests for the above purpose will be as given in the ANNEXURE-I.

3. The Ministry of Health and Family Welfare has informed that the above rates were offered to CGHS empanelled private hospitals in Delhi and NCR and the 26 hospitals given in ANNEXURE-II have accepted the offer and agreed to conduct the Annual Medical Examination of the Group 'A' Officers of Central Civil Services of 40

years and above. The Ministry of Health and Family Welfare is in the process of empanelling hospitals in other CGHS cities on the same terms and conditions. In non-CGHS cities the offer is being made to the hospitals recognized under CS(MA) Rules, 1944. Ministry of Health and Family Welfare has indicated that it will require atleast three months time for empanelling the hospitals for other places outside Delhi/NCR where CGHS/CS(MA) recognized hospitals are available. This will be communicated later. There are places where there are no empanelled hospitals. In such places, the administrative Departments/offices may engage quality local hospitals on the same terms and conditions to get the Annual Medical Examination of their officers conducted subject to ceiling of Rs.2000 and Rs.2200/- for men and women officers respectively or actual whichever is less.

4. All Ministries/Departments are accordingly requested to cater the estimated expenditure in their budget for reimbursement of the amount to the concerned officer and implement the scheme during the financial year 2012-13 for the officers located in Delhi and NCR. Instructions with respect to officers located outside Delhi/NCR where CGHS/CS (MA) recognized hospitals are available would follow. The concerned officer may be handed over the copy of complete Medical Report and the summary of the Medical Report in the enclosed proforma (**Annexure-III**) separately prepared by the Medical Authority is to be attached to the APAR of the concerned officer.

The scheme of Annual Medical Checkup for Group 'A' officers of Central Civil Services /posts of and above the age of 40 years was introduced by DoPT vide its OM NO. 21011/1/2009-Estt. (A) dated 1st Feb. 2012. It was mentioned therein that the summary of the Medical Report in the prescribed proforma (Annex. III of OM) prepared by Medical Authority to be attached to the APAR of the concerned officer.

2. It has been observed that such reports of Annual Medical Examination are being received from very few ICAS officers.
3. In order to ensure the adherence to regular Annual Medical Examination from the Year 2023-24 onwards, all ICAS officers of and above 40 years of age need to undergo Annual Medical Examination.
4. The APAR format in SPARROW shall be modified for indicating/attaching the same by the ICAS officers. In the meanwhile, all ICAS officers of and above 40 years age are advised to undergo Annual Medical Examination during the course of the year 2023-24 as per DoPT Scheme mentioned above.

Dear Sir / Madam

As a result of continued efforts of CBIC for the welfare of its staff and officers, a Scheme for financing the Annual Medical Examination for Group 'B' and Group 'C' officers/ staff working under the CBIC, has been approved by the Governing Body of the Welfare Fund. The Scheme covers all the tests which are available to the Group 'A' officers under Annual Medical Examination being implemented by DoPT.

2. The salient features of the Scheme are as under:

- (i) Scheme is applicable for all Group 'B' & 'C' officers/staff of age 40 years and above.
- (ii) Annual Medical Examination of the officers/staff is subject to ceiling of Rs. 2000/- and Rs. 2200/- for men and women officers respectively or actual whichever is less.
- (iii) For the sake of convenience, better coordination and swiftness, it has been decided to implement the Scheme at the level of Zonal Pr. Chief Commissioners/ Chief Commissioners who are also Cadre Controlling Authorities of the anticipated beneficiaries. The Zonal Pr. Chief Commissioners/ Chief Commissioners shall enter into Memorandum of Agreement (MoA) with CGHS empanelled Hospitals/ Diagnostic Centers or Hospitals/ Diagnostic centres recognized under CS (MA) Rules. Where there are no CGHS facilities, MoAs shall be entered into with reputed quality local Hospitals/Diagnostic Centres on the lines of MoAs entered by Ministry of Health & Family Welfare to empanel them for conducting the requisite tests of eligible departmental officials of Group 'B' and Group 'C' subject to the ceiling rates latest by **31<sup>st</sup> March, 2020**. List of such Medical Facilities with which the MoAs have been entered into, shall be submitted to the DGHDRD by the Zonal Pr. Chief Commissioners/ Chief Commissioners.
- (iv) The Scheme shall be implemented from 1<sup>st</sup> April, 2020. The Zonal Pr. Chief Commissioners/ Chief Commissioners shall prepare a list of anticipated departmental officials of Group 'B' and Group 'C' who are of 40 years and above as on **1<sup>st</sup> April every year** (The Cut-off date) who are eligible under the Scheme.
- (v) All the eligible Departmental officials of Group 'B' and Group 'C' shall undergo the requisite tests in the empanelled hospitals/ diagnostic centers latest by **31<sup>st</sup> July every year**. The Hospital/ Diagnostic centre shall hand over a copy of complete Medical Report & the summary of the medical report to the officer, and the officer shall give a satisfaction rating to the facility, while submitting his bill to the Administrative Authority.
- (vi) The HoD of the concerned departmental officials shall ensure that all eligible officials undergo the Annual Medical Examination by the prescribed timeline. The bills from the empanelled hospitals shall be duly examined and verified by the HoDs based on which, a consolidated Demand for Grant alongwith a report detailing the eligible officials and the officials who have actually undergone the Medical Examination and consolidated satisfaction report as mentioned at S. No. 2(iv) above shall be forwarded by the Zonal Pr. Chief Commissioners/ Chief Commissioners, to DGHDRD latest by **31<sup>st</sup> August of every financial year**, for sanction and release of funds from Welfare Fund.

(vii) DGHRD will submit the consolidated demands alongwith the reports for consideration and sanction of the Governing Body.

3. Wider publicity for Annual Medical Examination Scheme for Group 'B' and 'C' may be done. It is felt that the provision of Annual Medical Examination would go a long way in timely detection of any diseases and improving the general Medical Health of the Departmental officials and would in turn contribute towards enhancing their performance. Any suggestion on the smooth implementation of the scheme is welcome.
