Information Sought : I had applied for a gun licence for which NOC is required from your department I had submitted a letter with supported documents related to NOC at your office located at Rajpur Road Dehradun in June 2023 to Mr Ranjeet Sing After this a report which has longitude and latitude of my address and other inquiry regarding me was dispatched from ranger office Kalsi to your Rajpur road office in August 2023 In January 2024 when I went back to office and ask about my NOC your officer said that he had not received any report regarding me and my NOC from ranger office Kalsi which they had already dispatched in August 2023 I do not know how your department did not received a official letter sent from your department office and where was it gone Then I collect the same letter from ranger office Kalsi and handover to Mr Ranjeet Singh who look after NOC for gun abd sit on 3rd floor at your wild life office in Rajpur Dehradun in the first week of January 24 That time he said that the respected officer was on leave After that I went to your office a number of times between 15 January to 25 January 24 You can check the visiting register But each and every time he said that NOC was not prepared yet was not Signed yet etc Than I told him that I have to go back to my job and I can not come back how my work will be done Then he told that he will prepare the the final report and will send NOC to DM office Dehradun after getting signature of respective officer But how shameful is this that the NOC was not received yet to DM office Dehradun altho more than 1 month has passed away after doing all formalities from my end to your department Now I want to know under RTI act 2005 1 How much time it take to prepare NOC for gun licence at your end when all doc are with you and all reports of ranger office are clear 2 Why report was not dispatched yet more than 1 month passed away after doing all formalities and submitting all documents 3 If your office has dispatched the report and NOC to DM office Dehradun than I want the Post Number and name of the person who has reseved the post at DM Office Dehradun to track my
